## Half Marathon 2024 draws 8,000 from 39 countries

PETALING Jaya city centre was abuzz with excitement when PJ Half Marathon 2024 kicked off from Laman Majlis Bandaraya Petaling Jaya (MBP).

The 34th edition of the marathon drew 8,000 participants from 39 countries.

MBPJ said in a statement that India led the 250-strong foreign contingent with 35 runners, followed closely by Japan with 28, Singapore with 21 and United Kingdom with 18.

"This increased international participation reflects the growing prestige of PJ Half Marathon, which continues to draw a diverse array of runners from across the globe," said MBPJ.

The event featured five categories, namely the 30km, 21km and

10km Opens, 5km Fun Run and a new 1km Anime-Themed Fun Run.

The marathon kicked off at 3.40am with an aerobics session followed by the flag-off of the 30km race by Petaling Jaya mayor Mohamad Zahri Samingon.

The Petaling Jaya District Police implemented phased traffic control to minimise disruptions on race day.

Some 100 traffic police officers and 80 MBPJ enforcement officers were deployed to ensure safety.

The PJ Half Marathon 2024 was organised by MBPJ together with Puncak Ventures SRA Sdn Bhd and Selangor Para Athletics Association.

## Fined for hiring illegal workers

A TOTAL of 1,225 compound notices have been issued to Malaysian business operators in Kuala Lumpur for employing foreign workers without valid work permit during several joint operations since January. In a statement, Kuala Lumpur City Hall (DBKL) said action was taken under the Licensing of Hawkers By-Laws (Federal Territory of Kuala Lumpur) 2016 and Wholesale Market By-Laws (Federal Territory of Kuala Lumpur) 2002.

Under one of the operations

called Ops Tebah (Operasi Tegas Banteras Aktiviti Haram), four premises were ordered shut for being fully run by

foreigners.

Ops Tebah is an integrated exercise with the police, Customs Department, Immigration Department and Domestic Trade and Cost of

Living Ministry.
"DBKL has carried out four Ops Tebah operations this year. "Of the 11 business premises that were being monitored under *Ops Tebah*, four were immediately shut down under Section 101(1)(v) of the Local Section 101(1)(v) of the Local Government Act 1976 for being run by foreign workers," said DBKL in the statement. Under another special opera-tions, DBKL said 59 more premises were monitored with

15 being ordered to cease

operations.

A total of 53 notices were also issued, 22 seizures carried out

and 22 investigation papers

and 22 investigation papers opened, City Hall added. The statement also said that during the series of operations in the first nine months of the year, a total of 2,261 items were seized.

"In several cases, DBKL rec-ommended the cancellation of business licences for local

employers involved."

DBKL shut down two premises
in Taman Maluri after it was

found to be managed by foreign

Canopies, stalls and other equipment were also seized and sent to the DBKL storage facility in Taman Miharja for process-

in Taman Minarja for processing and documentation.
In another raid on Sept 25, four premises without valid business licences run by foreign workers were also shut

"Continuous enforcement will be carried out in Kuala Lumpur through periodic operations," DBKL added.

Insaf Malaysia has until Oct 14 to move out from Lot 30528 in Jalan Setiawangsa 8A, Taman Setiawangsa, which is located behind its headquarters.

This amount contributed to SIBS 2023's overall recorded value of RM6.12bil.

SABC 2024 featured 27 speakers and panellists from Asean member countries and Timor-Leste, attracting over 500 attendees, including over 200 international delegates.

# Ready to ride out storms

Authorities say pre-emptive plans in place to face disasters

PETALING JAYA: The Fire and Rescue Department will monitor 5,648 flood-prone areas, 254 critical slopes and 201 water surge hotspots nationwide during the northeast monsoon season starting next month.

Its director-general Datuk Nor
Hisham Mohammad said the
need for early preparations is
even more critical, given the
Malaysian Meteorological Department's (MetMalaysia) forecast of

manaysian intereorological Department's (MetMalaysia) forecast of above-average rainfall due to the developing La Nina weather phenomenon.

"Based on our data as of Sept 4, the territories of Sarawak and Sabah have the highest number of flood-risk areas and critical slopes, followed by Pahang, Johor and Kelantan," he told *The Star*.

A total of 1,006 flood-prone areas, 21 critical slopes and 19 potential water surge locations were identified in Sarawak, while 798 flood-prone areas, 36 critical slopes and 52 potential water surge locations were found in Sabah.

There are 750 flood-prone areas, 25 critical slopes and three potential water surge locations in Pahang, 745 flood-prone areas, 25 critical slopes and five potential water surge locations in Johor; while Kelantan has 617 flood-prone areas, 25 critical slopes and 18 potential water surge locations.

Earlier this month, MetMalaysia deputy director-general (strategic) Ambun Dindang said the 2024/2025 northeast monsoon will begin in November and continue until March 2025, with an expected four to six episodes of prolonged heavy rainfall during this period.

Heavy rainfall is likely to affect Kelantan, Terengganu and Pahang between November and December — with Johor, Sabah, and Sarawak expected to experience increased rainfall from December through January.

MetMalaysia also forecast above-average rainfall of between 20% and 40% for the next six months in several parts of the country.

It said there is a 71% chance for the La Nina weather phenomenon to form between October and November this year, which usually brings about wetter weather conditions, and it is expected to continue until early 2025.

Meanwhile, Nor Hisham said the department has activated preparedness plans, including placing its personnel on standby, due to the uncertain weather conditions brought about by the forthcoming monsoon and La Nina.

He said a total of 24,671 fire-men based in 340 Fire and Rescue stations nationwide will be ready to respond in the event of floods or other disasters.
"If the situation demands, the

"If the situation demands, the department will freeze or limit leave to between 80% and 100%.

"The work shifts will also be extended from 12 hours to 24 hours to ensure that there will be sufficient personnel to respond to flood emergencies.

"This includes sharing personnel and equipment between states if a particular state is hampered by personnel issues,"

he added

Nor Hisham also said 22 "Red Team" units, comprising a com-mander and four rescue person-nel, will be on rapid emergency deployment within an hour upon

deployment within an hour upon receiving orders to respond. He said these teams will be on call around the clock and act swiftly to shorten response time.

Meanwhile, National Disaster Management Agency (Nadma) director-general Datuk Khairul Shahril Idrus said the agency has also begun to deal with incidents of natural disasters brought about by the weather.

"We are conducting continuous exercises to gauge the level of preparedness of our responders, non-governmental organisations and local communities.

"This includes issuing the necessary guidelines to the relevant government agencies and state governments, including at the community level, on how to handle such disasters," he said when contacted yesterday.

Khairul Shahril said the focus should not only be on how to tackle floods but also on other natural disasters that often occur due to excessive rainfall and turdue to excessive rainfall and turdue.

"We usually focus on floods, and rightly so because floods can affect a large area with thousands

### Stay vigilant as northeast monsoon arrives early

PUTRAJAYA: The public is urged to stay vigilant and prepare for potential flooding, as the northeast monsoon is expected to arrive earlier this year, possibly beginning in the fourth week of October.

Deputy Prime Minister Datuk Seri Dr Ahmad Zahid Hamidi said that while this seasonal change typically occurs in early November, it is anticipated to start earlier this year due to changing weather patterns.

"Given the forecast indicating that the monsoon will hit earlier, we are making the necessary preparations," he told the media after the closing ceremony of the Rakan Nadma (National Disaster Management Agency) Convention: Malaysia Madani, Siaga Bencana event, held yesterday.

Ahmad Zahid, who also chairs Nadma, said the Department of Irrigation and Drainage has identified specific areas at risk of flash floods and emphasised the need for mobilisation through cooperation with state and district disaster committees, Bernama reported.

Ahmad Zahid said the

ter committees, Bernama reported.

Ahmad Zahid said the Malaysian Meteorological Department (MetMalaysia) will issue a warning five days before anticipated flooding in areas prone to heavy rainfall and high tides, aiming to mitigate risks.

Regarding the readiness of machinery and enforcement personnel, he indicated that the current numbers are adequate, as

machinery and enforcement personnel, he indicated that the current numbers are adequate, as mobilisation will occur collaboratively among enforcement agencies and non-governmental organisations (NGOs).

He emphasised that this mobilisation will be conducted in a structured manner, ensuring that no state or region is marginalised. Ahmad Zahid also urged flood victims to assist themselves and their families in relocating to safe areas rather than relying solely on enforcement agencies for rescue efforts.

Earlier, he launched the Rakan Nadma Rejuvenation Plan 2030, designed as a reference document for various stakeholders to plan, implement and monitor programmes that positively impact vulnerable groups while enhancing volunteerism and strengthening the humanitarian sector.

The plan outlines three working groups within Rakan Nadma to serve as a guide to enable members to fulfil their respective roles more effectively and relevantly.

"Kesiapsiagaan dilakukan oleh semua agensi penguatkuasaan dan badan bukan kerajaan (NGO) serta mobilisasi dijalankan secara berstruktur.

"Hari ini (Selasa) juga kita menyaksikan kertas dasar dilakukan dengan kerjasama Universiti Teknologi Malaysia (UTM) yang mengkoordinasi kerjasama di antara NGO untuk melakukan rejuvenasi bagi mengurangkan risiko bencana," katanya selepas merasmikan Konvensyen Rakan Nadma di sini pada Selasa.

Menurutnya, Jabatan Pengairan dan Saliran (JPS) telah mengenal pasti kawasan berisiko terutama banjir termenung di Pantai Barat Semenanjung bermula Perlis sehingga Johor.

Pengerusi Jawatankuasa Pengurusan Bencana Pusat (JPBP) itu berkata, Jabatan Meteorologi Malaysia akan mengeluarkan amaran lima hari lebih awal sebelum berlaku hujan melampau atau air pasang besar.



KUALA LUMPUR - Bank Negara Malaysia (BNM) dijangka mengekalkan kadar dasar semalaman (OPR) bagi tempoh 12 hingga 15 bulan akan datang, susulan tekanan inflasi mereda dan prospek ekonomi lebih cerah.

Bagaimanapun, Kenanga Investment Bank Bhd (Kenanga) berkata, peralihan dasar fiskal dan risiko luar seperti ketegangan geopolitik masih boleh mempengaruhi pen-

dirian bank pusat itu.

Dalam nota penyelidikannya pada Selasa, bank pelaburan itu turut menyemak naik unjuran nilai ringgit berbanding dolar Amerika Syarikat (AS) kepada 4.25 daripada 4.42 sebelum ini, disokong oleh perbezaan hasil, pengurangan kadar faedah oleh Rizab Persekutuan AS (Fed) dan pemulihan ekonomi China.

"Seperti dijangkakan, pasaran telah melakukan pelarasan dan menerima hanya dua pengurangan 25 mata peratusan tahun ini oleh Fed, susulan data tenaga kerja September yang lebih kukuh daripada

unjuran awal.

"Walaupun asas-asas domestik akan terus mendorong peningkatan ringgit, kami kekal berhati-hati terhadap risiko luar, khususnya prospek penurunan ekonomi AS yang mendadak, ketidaktentuan susulan Pilihan Raya Presiden dan ketegangan geopolitik," katanya. - Bernama

## Negara berpendapatan tinggi menjelang 2027

Kuala Lumpur: Malaysia berupaya mencapai negara berpendapatan tinggi menjelang 2027 jika ringgit kekal pada paras semasa sekitar RM4.20 berbanding dolar Amerika Syarikat (AS), demikian menurut Bank Dunia.

Ketua Ekonomi Bank Dunia bagi Malaysia, Dr Apurva Sanghi berkata dengan andaian ringgit berbanding dolar AS berada pada paras RM4.54 sedolar dan purata pertumbuhan ekonomi tahunan sekitar 4.3 peratus, Malaysia boleh mencapai negara berpendapatan tinggi menjelang 2028.

Katanya, pihaknya melihat Malaysia sebenarnya mencatatkan prestasi output perkapita yang mengatasi kebanyakan negara di Asean lain.

negara di Asean lain.

Malah, katanya, pertumbuhan perkapita Malaysia, pengukuran yang lazim digunakan oleh ahli ekonomi bagi mengukur kebajikan, juga dilihat lebih tinggi berbanding paras ketika sebelum pandemik iaitu meningkat 12 peratus.

### Penurunan harga minyak beri ruang turun belanja subsidi petrol RON95

Kuala Lumpur: Penuru-nan harga minyak dunia dan pengukuhan ringgit dijangka memberi ruang kepada kerajaan dalam Belanjawan 2025 mengu-rangkan perbelanjaan subsidi petrol RON95, se-kali gus mencapai matlamat pengukuhan fiskal serta pengurusan kos sa-ra hidup rakyat. Menurut CIMB Securi-

Menurut CIMB Securities, subsidi untuk petrol RON95 telah berkurang daripada RM1.10 seliter pada Jun 2024 kepada sekitar 65 hingga 70 sen seliter pada masa ini.

Berdasarkan anggaran harga minyak pada AS\$70 setong dan kadar tukaran dolar Amerika

tukaran dolar Amerika Syarikat (AS) berbanding ringgit pada RM4.22, subsidi unit dijangka

mencecah 55 sen seliter, dengan jumlah keseluruhan subsidi RON95 dianggar sebanyak RM8.9 bilion pada 2025.

Ini lebih rendah berbanding RM14.5 bilion pada 2024 yang diunjurkan berdasarkan harga minyak AS\$77 setong.

Penjimatan subsidi ini memberi kerajaan kelonggaran untuk meneruskan usaha pengukuhan fiskal tanpa menjehan fiskal tanpa menje-jaskan bantuan kepada

golongan rentan.
Ini penting memandangkan petrol me-nyumbang 5.5 peratus Indeks Harga Pengguna (IHP), menjadikan faktor utama dalam ramalan inflasi berbanding diesel menyumbang 0.2 peratus kepada bakul IHP.

# AI use exposes organisations to more threats

RTIFICIAL intelligence (AI) is opening up large organ-isations to more cyber threats, an industry report finds.

United States-based network security and cloud computing solutions provider Palo Alto Networks provider Palo Alto Networks analysed from several petabytes of data collected throughout 2023, and found that organisations faced mount-ing challenges safeguarding their IT infrastructure amid the relentless change and heightened risk posed by

Al-generated threats.
Its 2024 Unit 42 Attack Surface
Threat Report highlights that critical sectors, including insurance, phar-maceuticals and manufacturing, are experiencing a continuous evolution in their attack surfaces, rendering them prime targets for cybercrimis nals exploiting Al-generated vulner-

'As businesses broaden their digi tal footprints, tracking and securing all assets become increasingly complex.

"Many organisations find it chal-lenging to maintain an accurate inventory of their Internet-facing applica-tions, leaving them vulnerable to cyber threats that often stem from software vulnerabilities," the company said.

Palo Alto Networks country man-ager for Malaysia Sarene Lee said

#### **KEY FINDINGS**

 Evolving attack surfaces: On average, organisations intro-duce over 300 new ser-

vices each month, which accounts for nearly 32 per cent of new high or critical cloud exposures. This rapid proliferation of new services, often without adequate oversight, leads to misconfigurations and increases the likelihood of breaches.

2. Increased risks from lateral movement and data exfiltration: Seventy-three per cent of high-risk exposures are located within IT and exposures are located within II and networking infrastructure, busi-ness operations applications, and remote access services, which can be exploited for lateral movement

and data exfiltration.

3. Critical IT and security infrastructure exposures: Over 25 per exposures relate to essential IT and networking infrastructure, creating openings for opportunistic attacks. This includes vulnerabilities in application-layer protocols and Internet-accessible administrative login pages for routers, firewalls, virtual private networkds, and other key networking and security Remote access services and busi-ness operation applications also comprise significant portions of exposure, each exceeding 23 per

4. Media and entertainment: This sector saw the highest rate of new services added, exceeding 7,000 per month.

5. Telecommunications, insurance, pharmaceuticals and life scienc-es: These industries experienced substantial growth, with more than 1,000 new services added to their

attack surfaces.

6. Critical industries: Financial services, healthcare and manufactur-ing observed an increase of over 200

new services each month.
The report also emphasises the necessity for organisations to adopt Al-driven tools, such as Cortex Xpanse, which offer continuous asset discovery

and inventory management.
This capability is vital for maintaining comprehensive visibility into the attack surface and minimising secu-

Zahid, who is the National Disaster Management (Nadma) Committee chairman, said the Department of Irrigation and Drainage had identified areas at risk, particularly those prone to

Drainage nad dentified areas at risk, particularly those prone to flooding. "Many incidents occur along the west coast of Peninsular Malaysia, from Perlis to Johor. In

the west coast of Peninsular Malaysia, from Perlis to Johor. In preparation for this, we are mobilising resources through state and district disaster committees. "Coordination meetings are held when the northeast and southwest monsoon seasons are anticipated."

He said all enforcement agencies and non-governmental organisations (NGOs) would be deployed with adequate personnel. "We do not focus on specific states or locations.

"This mobilisation will be structured, incorporating support from NGOs."

Zahid emphasised the importance of public preparedness to mitigate disaster risks.

"The Malaysian Meteorological Department (MetMalaysia) will issue warnings five days before extreme rainfall or high tides are expected.

"We will communicate this

mittees.
"We urge the public to heed evacuation advisories to min-imise the impact of disasters."

### 29 areas in KL to face water disruption

KUALA LUMPUR: A total of 29 areas around the federal capital will experience unscheduled water supply disruptions due to emergency repairs on a burst pipe at Hub Pasar Seni here. Pengurusan Air Selangor Sdn Bhd (Air Selangor) said in a statement that the affected areas include Apartment

Putra Ria, Brickfields, Bukit Bandaraya, Bukit Bangsar, Bukit Damansara, Bukit Persekutuan, Bukit Tunku, Damansara Heights, Damansara Town Centre, Idamansara and Jalan Sultan Hishammuddin, Bernama reported. It said repairs are expected to be completed by 1am today and water

would be distributed in stages once the main water supply distribution system has stabilised.

"The recovery period will differ depending on the location of the consumer's premises and water pressure in the distribution system."

Water tankers will be mobilised to

the affected areas, with priority given to critical premises such as hospitals, clinics and dialysis centres.

## Salary adjustments should enhance public service delivery

This process of developing and formulating the PSRS reflects the government's values and principles of

transparency.

PSRS is one of the governments initiatives to reform the public service towards achieving the goals and agenda of Malaysia Madani.

One of the key highlights of the PSRS is to review the salaries of civil servants across all schemes and grades.

grades.

At a time when all countries in the world, including Malaysia, are struggling to cope with various challenges and socioeconomic situations, especially with the rising cost of living and increasing price of goods, the introduction of the PSRS is timely.

of goods, the introduction of the first is timely.

The announcement by the prime minister recently on the PSRS, which among other things, involves the adjustment of civil servants'salaries of between seven to 15%, was highly anticipated by all civil servants.

The PSRS will be implemented in phases starting with the first phase on Dec 1, followed by the second phase in 2026.

However, the PSRS is more than However, the PSRS is more than just a salary adjustment for civil servants. The prime minister also placed great emphasis on the importance of increasing the quality

of public service delivery.

Therefore, PSRS has been formulated as a performance-based system to optimise resources, increase work productivity, ensure effective human capital management and development, enhance leadership and good governance, and

improve service delivery.

One of the milestones of PSRS is the revision of the minimum entry the revision of the minimum entry qualifications into the civil service. Cuepacs (Congress of Unions of Employees in the Public and Civil Services) welcomes this aspect, and it indirectly reflects the advancement and educational achievements of the people in the country.

Higher educational attainment of civil servants at the entry-level will elevate the overall image and dignity of the civil service.

This move demonstrates alignment and

harmonisation of the policy that will streamline as well as maintain consistency and uniformity in public services across different levels of

services across different levels of government.

Though the outcome is yet to be seen, PSRS will have a positive impact on the 1.6 million civil servants and attract as well as retain the best talent in the civil service because the new remuneration system will almost be senter that the private sector. on par with the private sector.

Therefore, civil servants should reciprocate by committing and dedicating to increase efficiency and productivity in the service delivery as a sign of appreciation to the government.

# 'We will take stern action against rogue officers'

KUALA LUMPUR: The Immigration Department has zero tolerance for rogue officers, including those allegedly linked to a medical visa syndicate facilitating the entry of migrants into the country, says its director-general.

Datuk Zakaria Shaaban said the department will not hesitate to act decisively against any officers found guilty of misconduct.

"Stern action will be taken regardless of rank or post. We are committed to ensuring no violation of integrity is committed, in line with the department's main focus to improve governance, discipline and integrity so that our image and reputation can be elevated in the eyes of society," he said in a statement yesterday.

He was commenting on an online portal alleging that the Enforcement Agency Integrity Commission (EAIC) was investigating several Immigration officers for their involvement in a medical visa syndicate.

The report claimed the depart-

The report claimed the department's visa syndicate was raided last week and documents seized.

Zakaria said the department will leave it to the EAIC to investigate the alleged involvement of some of its officers with the syndicate.

He confirmed that the EAIC had come to the department headquarters to investigate the alleged integrity infringement.

"We will cooperate transparently and justly," he added.
