Subang Racquet & Golf Centre faces demolition amid plans for high-rise apartments

KUALA LUMPUR — The Subang Racquet and Golf Centre is expected to be demolished and redeveloped into a high-rise apartment complex in the coming months.

The six-acre plot—located approximately 650 metres from the Nu Empire Shopping Gallery and 950 metres from Subang Parade—was reportedly sold by Sime Darby Property Berhad to LTS Capital Sdn Bhd last year for the

However, the proposal for the multi-million ringgit project has yet to be submitted to or approved by the Subang

According to a source, several residents' groups in Subang Jaya have expressed dissatisfaction with the proposed development, citing concerns over increased congestion and other negative implications.

"The developers are currently engaging with local residents and stakeholders to gather feedback on the project.

"It seems that several residents' groups are unhappy with the idea of a new commercial development, as they believe it would lead to unnecessary congestion and place further strain on the existing infrastructure.

"There's only one main road providing access to the area, and there are already too many transit-oriented developments in Subang Jaya.

The source noted the project could still be approved, as a recent closed-door meeting saw low turnout from residents, with only four of 13 invited groups attending. — Instagram pic, April 15, 2025

"As this is a commercial development, only a plot ratio of 1:4 is allowed. However, if the developers are aiming for a higher ratio—such as 1:6, which is becoming increasingly common—they would need to initiate discussions with residents and the relevant government agencies to assess the feasibility.

"No formal proposal has been submitted to MPSJ yet, but it may happen soon," the source said.

At the same time, the source noted there is still a strong possibility the project could gain approval, as not all residential groups are opposed to it.

It is understood that a recent closed-door meeting was held to gather residents' views on the proposed development.

Thirteen groups were invited, but only four attended.

"Even from a commercial standpoint, the project may not be viable. It could add more pressure to existing businesses in the area—many of which are already struggling, such as Subang Parade, AEON Big Subang, and several others.

"Only Sunway Pyramid seems to be thriving. There is also a lack of unity among the residents' groups. If resistance remains weak, the project stands a strong chance of being approved by MPSJ.

"The fate of the project will ultimately be decided in the coming months," the source added. — April 15, 2025

State expedites diesel storage approvals to support businesses amid gas supply cut

SHAH ALAM, April 16 — The Selangor government is expediting local authority approvals for businesses to store diesel on site to cushion the impact of the gas supply disruption after the April 1 Putra Heights pipeline explosion.

State executive councillor for investment, trade and mobility Ng Sze Han said the initiative is one of several urgent steps being taken to support companies, particularly those dependent on cold storage, in keeping raw materials intact and maintaining operations.

"We are also in constant communication with PetGas (Petronas Gas Bhd) and other stakeholders to accelerate the full restoration of gas supply," he told Media Selangor during Invest Selangor's Aidilfitri Business Networking 2025 event held at the MBSA Convention Centre here yesterday.

Ng, who chaired a stakeholder engagement session on April 9, said the meeting gathered representatives from the state administration, the Energy Commission, the Federation of Malaysian Manufacturers (FMM), PetGas, pipeline operator Gas Malaysia Bhd, and impacted industry players.

Yesterday, he said he is constantly engaging with industry players and FMM's affected members to find the best way forward.

The blast on April 1 disrupted the Segamat-Kapar sector of the Peninsular Gas Utilisation pipeline, a critical transmission route supplying gas to industrial zones in Selangor.

As a result, affected manufacturers have been forced to scale back production or switch to more expensive alternatives, such as diesel or fuel oil.

In a report published on Monday by The Edge, Ng acknowledged the economic impact of the incident is still being assessed, but confirmed certain sectors are already suffering.

While the state government's priority remains the welfare of displaced residents, Ng said efforts are also underway to ensure the swift recovery of the industrial ecosystem.

Industries such as steel manufacturing, rubber gloves, food and beverage, and pharmaceuticals are among the most reliant on liquefied natural gas.

While some operations, such as those using boilers, can temporarily shift to alternative fuels, others that rely directly on gas for key processes like melting or heating have no immediate substitute

The Energy Commission is currently prioritising gas supply to essential services, including power generation, hospitals, food processing, and pharmaceuticals.

Industry players, however, continue to contend with reduced gas pressure and partial

Meanwhile, Selangor State Legislative Assembly Speaker Lau Weng San indicated that the upcoming assembly sitting, expected in July, will include a debate on the incident, especially on the need for buffer zones between industrial infrastructure and residential areas

"The matter is still under investigation, and I am certain the executive will carry out their duties to resolve the problem.

"The legislative will definitely discuss and debate this issue, and I hope there will be more vigorous debate, especially on proposals to establish safer routes and buffer zones.

"All developments within each local council are subject to the local plan. Therefore, the debate should focus on the buffer zone distance outlined in the plan. In this case (Putra Heights), under the MBSJ (Subang Jaya City Council)," he said in a press conference yesterday.

He added that future development plans, especially those under local authorities like MBSJ. must place greater emphasis on safety, particularly in high-risk industrial areas.

The Putra Heights blast on the second day of Aidilfitri triggered a massive blaze, with flames reaching over 30m high and temperatures soaring to 1,000°C.

The fire took nearly eight hours to extinguish.

The incident affected 219 homes — 81 destroyed and another 81 damaged — and impacted 1,254 residents from 308 families.

ENFORCEMENT against illegal foreign traders in Kuala Lumpur has been stepped up following public concerns about the proliferation of such businesses. Between April 1 and 13, six raids were conducted by Kuala Lumpur City Hall (DBKL) at hotspots.

These included Jalan Leboh
Pudu and Jalan Tun Tan Siew

Several roadside traders selling food and beverages in front of the PETRONAS Twin Towers and Pavillion Kuala Lumpur were also in the area covered by the DBKL operations. In media statements, City Hall said its enforcement officers were continuously monitoring

said its enforcement officers were continuously monitoring businesses operating without a licence, especially by foreigners, "DBKL will step up inspection at hotspots to ensure all business activities comply with regulations

with regulations.

"Those with information about businesses being operated by foreigners are encouraged to submit the details at adukl.dbkl. gov.my," it said.

During an operation on April 12 in Jalan Leboh Pudu and Jalan Tun Tan Siew Sin, DBKL

made 16 asset seizures.

DBKI. had also conducted operations in Jalan Petaling, Jalan P. Ramlee and Masjid Jamek, and carried out 19 asset

seizures involving mostly traders selling food and beverages.

A similar action was taken during an operation on April 1 at Jalan Silang, Jalan Bukit Bintang and Jalan Khoo Teok Ee involving nine traders.

Planetary Health Matters

MOST of us know that plastic pollution is a major problem. We see it on our streets, in our rivers, on our beaches, and even in the stomachs of marine life. We read about the worrying effects of microplastics on human and planetary wellbeing.

But many of us are less aware that governments worldwide have been negotiating a global plastics treaty to tackle this crisis. This treaty could change the way plastics are produced, used, and disposed of across the world. However, progress has not been as fast as many have hoped, and corporate interests have led to some foot-dragging at the bargaining table.

In response to the growing plastic

In response to the growing plastic pollution crisis, governments agreed in 2022 to develop a legally binding treaty under the auspices of the United Nations Environment Programme. The 2022 United Nations Environment Programme. The 2022 United Nations Environment Assembly Resolution on ending plastic pollution includes a reference to the development of an international binding instrument which addresses the full lifecycle of plastic. Achieving this means setting legally binding global reduction targets on plastic production, ensuring safer alternatives, and reducing the amount of plastic that ends up polluting our planet.

When negotiators gathered in Busan in South Korea late last year for the fifth session of the Intergovernmental Negotiating Committee (INC-5) on the Global Plastics Treaty, there was hope that real progress would be made in tackling one of the planet's most pressing crises. But INC-5 ended in deadlock, with vested interests watering down ambitions and preventing the approval of the agreement. Now, as we head towards the crucial resumed session INC-5.2 – which is a make-or-break moment – we must face an uncomfortable truth: plastic pollution is not just an environmental issue, it is a symptom of a ruth: plastic pollution is not just an envi-ronmental issue, it is a symptom of a deeper crisis of human behaviour, eco-nomic greed, and political inertia. We live in a world where plastic has become so embedded in our daily lives

become so embedded in our dally lives that we barely notice it. From the moment we wake up and squeeze out toothpaste from a plastic tube to the coffee we sip from a takeaway cup with a plastic lid, we participate in an unsustainable system designed for convenience at the expense of planetary health. Every minute, the equivalent of a truckload of plastic enters the ocean. Microplastics now contaminate the air we breathe, the water we drink. the air we breathe, the water we drink, and are found in our bloodstreams,

and are found in our bloodstreams, brains, lungs, and even in unborn babies. The science is unequivocal: the overproduction of plastics is fuelling a planetary crisis. The fossil fuels driving climate change are the same ones feeding plastic production. And despite the glossy promises of recycling, globally only around 9% of plastics are recycled. The rest ends up in landfills, incinerators, fields, rivers, oceans, and our food. But we act as though this crisis belongs to someone else though this crisis belongs to someone else

– as if governments, corporations, or sci-entists will step in and fix it. And while

Why was it difficult to conclude the negotiations at INC-5? It was in large part because the same industries that profit from plastics are using their influence to block an ambitious, legally binding treaty. They argue that voluntary commitments and national-level regulations are enough, and that many of the issues which the treaty sets out to address are already covered by cristing international agreements. treaty sets out to address are already covered by existing international agreements. But we have seen this play out before, whether with climate change, tobacco control, or hazardous chemicals. Without an enforceable, global agreement that tackles plastics from production to disposal – an "end-to-end" treaty – the crisis will only described.

al – an "end-to-end" treaty – the crisis will only deepen. Rich nations, particularly those hosting powerful petrochemical companies and petro-states, are resisting regulations that would curb plastic production. Meanwhile, developing nations, many of which bear the brunt of the plastic crisis, struggle with inadequate waste manage-ment systems. The solution cannot be a piecemeal approach where only certain types of plastic are banned or where types of plastic are banned or where responsibility is shifted onto consumers through ineffective recycling campaigns. We need a globally implementable com-mitment to cut plastic production at its

demand action, governments respond.
The Montreal Protocol of 1987, which successfully phased out ozone-depleting substances, was made possible by public and scientific pressure. The Paris Agreement on Climate Change of 2015, while imperfect, exists because millions of respondence to the total streets demanding climates. people took to the streets demanding cli-mate action. The plastics crisis demands the same level of urgency and mobilisa-

Governments will not act boldly unless we force them to. Industry lobbyists and their public relations experts will not back down unless their influence is outweighed

down unless their influence is outweighed by public pressure. We must call on our governments to support a treaty that:

> Caps and phases down plastic production, rather than just addresses the waste aspect of the lifecycle of plastics.

> Holds corporations accountable for their role in plastic pollution, including through taking responsibility to clean up after themselves.

> Bans harmful chemicals in plastic pro-

· Bans harmful chemicals in plastic pro-

> Ensures a just transition for workers in the informal sector and the entire plastic value chain.

> Provides funding and technology transfer for low-income nations to build sustainable waste management systems, including manufacturing plastic alterna-tives from agricultural waste. This is not just a battle for policymakers

in negotiation rooms. It is a battle for all of us. As individuals, we can reduce our plastic use, support businesses that are plastic-free, and educate those around us.

plastic-free, and educate those around us. But more importantly, we must pressure our governments to stand on the right side of history at INC-5.2 in August. Write to your representatives, join campaigns, and raise your voice on social media.

The industries profiting from plastic pollution are counting on public apathy. We must prove them wrong. We are already seeing wooden toothbrushes in the market and restaurants that no longer provide drinking straws. Demand creates supply and we need to demand more from the industry.

A united approach to tackling plastics pollution is within reach – but only if we demand it. The stalemate of INC-5 should not discourage us; it should fuel our determination. The planet cannot afford another weak compromise. This time let's get the treaty we need across the finish

Obstructive practices in Brickfields

Repairs on tactile paths meaningless without proper enforcement, say stakeholders

REPAIRING broken tactile paving blocks to help the visually impaired walk safely in Brickfields, Kuala Lumpur, is a half measure, says stakeholders. The ongoing work will amount to naught if nothing is done to stop people from blocking these paths.

While the repairs are welcomed, the blind community wants Kuala Lumpur City Hall (DBKL) to tackle the issue of illegal stalls and illegally parked motorcycles and cars blocking these walkways.

These obstructions are not just inconveniences – they are the very reason the tactile paths keep breaking in the first place, said Malaysian Association for the Blind (MAB) chief executive officer Datuk George Thomas.

"What is the point of fixing them if they are going to be damaged all over again next week?" he said.

DBKL began works to repair the tiles in February following

he said.

DBKI began works to repair the tiles in February following repeated complaints from the sight-impaired community.

However, Thomas said sustainability – not just surface-level repairs – was key.

"The only way this is going to work is to clear the walkways," he emphasised.

Brickfields, proclaimed as

Brickfields, proclaimed as
Malaysia's "blind-friendly" township, has in recent times struggled with accessibility, which
stakeholders claim is due to weak enforcement and unchecked urban clutter.

Tactile paths designed to guide the visually impaired often lead

nowhere, or worse, into danger. "Fixing the tiles is one thing, but if there is no follow-through, we are just going in circles," said Sharifah Aminah, a visually-im-

paired resident.

"I have always prided myself on being able to navigate Brickfields with just my walking stick, guided by the tactile blocks.
"But the township has become a dangerous place for people like "mo."

Sharifah complained that the tactile guides were frequently blocked, damaged or rendered unusable.

Her experience reflects the broader concerns of the blind community, who say that without firm and consistent enforcement, DBKL's repairs will be short-lived.

In response, DBKL has kickstarted efforts to make Brickfields safer under the CHASE City agenda, championed by Minister in the Prime Minister's Department (Federal Territories) Datuk Seri Dr

Thomas says the obstructions are inconvenient and the reason the tactile paths keep breaking.

Zaliha Mustafa. CHASE City represents Dr Zaliha's vision to transform all Federal Territories, including Kuala Lumpur, into Clean, Healthy, Advanced, Safe and Eco-Friendly cities. Brickfields Rukun Tetanga

lt is commonly assumed that homeowners can recover compensation through fire insurance policies. But this is only possible if adequate home fire insurance has been purchased beforehand.

While fire insurance is generally a prerequisite for mortgaged homes, owners of older, fully-paid properties may lack sufficient or any coverage, leaving them to bear the loss themselves.

Even where fire insurance exists, it typically covers only structural damage and fixed fittings. High-value movable items such as laptops, mobile devices and entertainment systems, often uninsured, may be excluded. Meanwhile, items of sentimental value are irreplaceable.

Meanwhile, items of sentimental value are irreplaceable.
For vehicles, owners who opted only for basic "third-party" insurance – common for older vehicles, motorcycles and commercial vehicles – are unlikely to be covered for fire-related damage. This potentially leaves many without financial recourse.

The explosion and subsequent suspension of gas supply in the area also disrupted operations at an estimated 200 nearby factories, including food manufacturers and metal processing facilities. In legal terms, these are examples of "pure economic loss" – financial losses that arise not from injury

Anor clarified that even if negli-gence is established, damages for pure economic loss may not be claimable. This significantly restricts legal remedies for the affected industries, and raises questions about whether our existing laws adequately reflect the economic inter-dependencies of modern industrial zones

Public scrutiny has turned to the roles played by the pipeline owner, the Energy Commission

(EC) and the local authority. Several key statutes govern these parties' responsibilities – the Gas Supply Act 1993 (Act 501), as amended in 2016; the Gas Supply Regulations 1997 (P.U.(A) 287]; the Energy Commission Act 2001 (Act 610); and the Street, Drainage and Building Act 1974 (Act 133).

As the licensed gas transporter in the affected area, the pipeline owner is responsible for the safety and maintenance of gas instal-

lations under the Gas Supply Regulations 1997. To date, there is no indication if the pipeline owner failed in these responsibili-

The EC's duties, as outlined in Section 4(1) of Act 501, includes the mandate "to protect the public from dangers arising from the distribution of gas through pipe-

Meanwhile, the local authority's responsibilities under Act 133

include the reported issuance of a permit for excavation works in the area prior to the incident.

the area prior to the incident.

However, statutory immunities complicate any imposition of liability. The EC is protected from certain legal actions under Section 37 of Act 501, while the local authority is protected under Section 95(2) of Act 133, as explained by the 2006 Federal Court case of Mailis Perhandara explained by the 2006 rederal Court case of Majlis Perbandaran Ampang Jaya v Steven Phoa Cheng Loon. These protections may limit the availability of legal

may infinit the availability of regal recourse against the public authorities involved.

While contractor negligence remains a possibility, it must be emphasised that legal liability emphasised that legal hability cannot be determined until inves-tigations are completed. Even if such negligence is established, questions remain about whether the contractor would have the financial resources or insurance coverage to compensate victims on this scale.

This underscores the impor-tance of mandatory liability insur-ance and stringent regulatory controls for high-risk works near

controls for high-risk works near critical infrastructure.
The Putra Heights explosion is a sobering reminder that as Malaysia advances its infrastructure and industrial capacity, our legal and regulatory systems must keep pace. Strengthening protections, closing insurance gaps and ensuring accountability are no longer optional: they are essential longer optional; they are essential to safeguarding lives and liveli-



Prinsip wakaf Fuqaha mendefinisikan wakaf berserta prinsipnya seperti berikut: "Menahan sesuatu berikut: Menahan sesuatu harta yang boleh digunakan tanpa susut fizikalnya dengan cara menyerahkan hak miliknya kepada seorang pengguna yang harus dan wujud."

Frasa 'tanpa susut fizikalnya' di dalam pentakrifan wakaf manifestasi amalan wakaf hendaklah berterusan seperti yang termaktub di dalam hadis di bawah:

Maksudaya, "Arabi!

Maksudnya: "Apabila seseorang manusia mati, segala amalannya akan terputus kecuali daripada tiga sumber iaitu sedekah jariah , ilmu yang boleh dimanfaatkan dan anak soleh yang sering mendoakannya." (Hadis Muslim No 1255)

Berdasarkan hadis Ibn Umar, Berdasarkan hadis Ibn Umar, jumhur fuqaha iaitu mazhab Hanafi, mazhab Syafii dan mazhab Hanbali berpandangan bahawa wakaf hanya sah dilakukan secara berkekalan (ta'bid). Justeru, sesuatu wakaf itu tidak sah jika dilakukan secara bertempoh (ta'qit), seperti berilut.

secara bertempoh (ta'qtt), seperti berikut: i. Imam Muhammad bin Hasan Al-Shaiban daripada mazhab Hanafi menyatakan wakaf hendaklah kekal (ta'bid). Beliau menegaskan bahawa kekal adalah salah satu syarat sah wakaf. Ini kerana amalan wakaf dianggan sebagai catu. wakaf dianggap sebagai satu sedekah jariah yang berterusan. Maka, sedekah jariah tidak boleh dibatasi dengan tempoh masa yang tertentu. Justeru, wajib bagi pewakaf

untuk menyatakan kekal di dalam sighah wakaf sama ada ia merangkumi lafaz dan makna ataupun cukup pada makna

sahaja. ii. Mazhab Syafii mensyaratkan kekal secara mutlak pada wakaf dan ia adalah tidak sah jika dilakukan secara bertempoh. Al-Shirazi menyatakan wakaf hendaklah dilakukan secara berkekalan kerana ia dianggap sebagai membelanjakan harta untuk kebaikan kerana Allah SWT. Harta yang diwakafkan hendaklah disalurkan kepada

penerima wakaf (mauquf alaih) yang tidak terputus seperti golongan fakir, miskin, dan penuntut ilmu. iii. Mazhab Hanbali turut

menyatakan wakaf hendaklah dilakukan secara kekal dan tidak

dilakukan secara kekal dan tidak dibenarkan untuk melakukan sebarang transaksi terhadap harta yang diwakafkan. Harta wakaf juga tidak boleh dikembalikan (ruju' al-waqf) kepada pewakaf selepas termeterai akad wakaf.

iv. Ulama kontemporari yang bersetuju dengan pendapat Ibn Qudamah menyatakan beliau lebih cenderung kepada mazhab Hanafi yang menyatakan wakaf tidak sah jika dilakukan secara bertempoh. Al-Raisuni juga menyatakan wakaf hendaklah dilakukan secara kekal kerana ia dianggap sedekah jariah (yang berterusan).

Desperate individuals sowing discord among fellow citizens, says Perak sultan

ULTAN of Perak Sultan Nazrin Muizzuddin Shah has expressed deep con-cern over the growing ten-dency among Malaysians to exploit racial and religious issues for personal or political gain, warning that such actions threat-en the nation's unity.

"Regrettably, as a nation, we appear to be drifting further from unity," he said.

passe spanning over a decade was ultimately resolved through di-alogue and mutual understand-ing among the involved parties,

ing among the involved parties, certain quarters persist in sensationalising the issue."

Sultan Nazrin said this at the opening of the 15th Term of the Perak State Legislative Assembly at Bangunan Perak Darul Ridzuan here yesterday.

Present was Raja Permaisuri Perak Tuanku Zara Salim.


Sultan Nazrin said what should have been seen as a triumph of negotiation and coexistence was now being manipulated for ul-

"What had been settled amicably is now being stirred, debated, and politicised in ways that unsettle public sentiment.

"At times, minor and localised matters relating to religion and ethnicity are deliberately magnified — manipulated to the extent that they risk igniting

"Issues of race and religion are increasingly sensationalised, often hijacked by desperate individuals seeking recognition as champions of their own community or faith — even if such actions sow discord and provoke antimosity among fellow citizens."

He expressed sadness over the rise of hate-driven politics, warning that it could steer the nation toward a bleak and divided fu-

"It is deeply saddening that hate-driven politics have become a preferred choice, and there are concerns that the nation may face a future where its people are divided, harbouring hatred and animosity towards each other. "The seeds of hatred are being

sown across the nation, eroding our moral compass and dimin-ishing our empathy when dealing with those who hold differing

He also observed a worrying increase in political slander and personal attacks.

"It is apparent that the culture of slander is becoming more ram-pant, with a growing acceptance of actions that seek to demean

and disgrace political opponents.

"The values of human decency and humanity seem to be fading away, and the truth itself appears to have lost its value and significance.

He also drew attention to a sector that demonstrates without fan-fare the true spirit of Malaysian unity - the nation's health ser-

unity — the hattor's health solve, vice.

"Beyond its explicit role of delivering healthcare and medical treatment, the health service plays an implied, often unspoken role — one that fosters unity across our diverse society; that across our diverse society; that across fixed patiently, bridging the across our diverse society; that manifests naturally, bridging the varied backgrounds of Malaysians—of different ethnicities, faiths, cultures, languages and social standing.

'Malaysia can no longer ignore environmental crisis'



IPOH: Malaysia is facing an environmental crisis that can no longer be ignored, warned Sultan of Perak Sultan Nazrin Muizzuddin Shah, who raised the alarm over the nation's worsening plas-tic pollution and illegal e-waste

tic pollution and illegal e-waste dumping.
Sultan Nazrin lamented over Malaysia's disturbing emergence as a key global destination for e-waste dumping, revealing that many processing factories oper-ate illegally, often hidden in plain

sight.
"These waste trafficking syndicates employ tactics such as fal-sifying documents and misrepresenting cargo.
"Illegal e-waste premises en-

gage in uncontrolled waste pro-cessing, leading to air, soil and water pollution," he said at the opening of the 15th Term of the Perak State Legislative Assembly

Perak State Legislative Assembly at Bangunan Perak Darul Ridzuan here yesterday.
He said the influx of e-waste required serious attention, as it contains toxic and hazardous materials.

"Improper disposal of such tox-ic waste poses significant risks to the environment and negatively impacts human health.

"Operating an e-waste process-ing factory without a permit is a

criminal offence.

"E-waste criminals, driven by narrow interests to profit, clearly

disregard the detrimental effects

on the ecosystem," he said. Sultan Nazrin remarked on the Sultan Nazrin remarked on the Feb 15 incident where RML3 bil-lion worth of goods were seized in a raid by authorities on an illegal e-waste processing factory in Sungai Siput. He said the incident raised se-

rious questions about how var-ious authorities overlooked the presence of a large factory promi-nently operating illegally in an open area.
"This incident should serve as

a wake-up call for all relevant authorities to intensify their monitoring efforts and enforce integrated, swift, and firm ac-

He added that the accumulation of plastic in our rivers and oceans now covers 40 per cent of the ocean's surface — a global crisis that must be addressed ur-

gently.

"This issue not only has a detrimental impact on the environ-ment but also threatens the sur-

nient out also threatens the str-vival of marine life, which in turn poses a risk to food security, "If immediate and effective control measures are not implecontrol measures are not implemented, researchers predict that by 2050, the amount of plastic waste in our oceans will surpass the fish population."

Sultan Nazrin said Malaysia, though a relatively small country, was unfortunately ranked as one

of the top five countries globally guilty for mismanaging plastic

guilty for mismanaging plastic trash.

"Each Malaysian indiscriminately disposes an average of 2.4kg of plastic annually.

"According to the United Kingdom-based Utility Bidder, Malaysia contributes to ocean pollution with 2.29kg of plastic per capita annually.

"The 'user pays principle' imposed on businesses to reduce plastic usage has proyen ineffec-

plastic usage has proven ineffec-

sures need to be introduced and implemented earnestly to tackle this growing environmental chal-lenge.
