Over 138,000 lots have no strata titles

Selangor task force discovers incomplete documentation, legal cost among reasons

THE special task force set up by Selangor to resolve issues on strata ownership has identified 138.817 lots without strata titles

Most of these lots are located in the Subang Jaya City Council (MBSJ) area with 35,780 lots, followed by Ampang Jaya Municipal Council (MPAJ) with 19,828 and Petaling Jaya City Council (MBPJ) with 16,963 lots.

State housing and culture committee chairman Datuk Borhan Aman Shah said this in reply to Lim Yi Wei (PH-Kampung Tunku) who inquired about strata ownership in the state, during the Selangor State Assembly at Bangunan Dewan Negeri Selangor in Shah

"The aim of the special committee set up by the task force to address this matter this year is to provide an inventory of all buildings without strata titles in Selangor," said

He also said some buildings did not have strata titles as incomplete documentation was submitted because building plans had not been approved by the local authorities.

"The amended Strata Titles Act 1985, which came into force in 2015, provided us the power to give exceptions and consider some applications for strata titles for specific buildings although the owner did not have the required documents."

He said another matter that hampered the process of obtaining the strata titles was legal cost.

"Until October, the special committee created the inventory and identified all the affected projects," he said, noting that the committee also managed to solve some strata

"Among them are projects in Bandar Tasik Puteri in Rawang involving 400 units," he

Borhan said the special committee was currently monitoring the progress at Taman Putra Perdana in Sepang, of which 784 units were at Pangsapuri Teratai and 350 units at Pangsapuri Seroja

PUTRAJAYA has a new commu-nity mediation centre (PMK) that will serve as a dedicated space for the public to seek help on

or me public to seek help of community matters. The disputes handled by the centre are those affecting resi-dential areas and neighbourly

relations.

These include parking space, pets, use of common areas and misunderstandings among

neighbours.
At the PMK located in At the PMK located in Putrajaya's Precinct 5, the public can get free advice from 33 trained mediators who are based in the administrative

capital.

The PMK was set up via a collaboration between the National Unity and National Integration Department (JPNIN), the proper-ty management division of the Prime Minister's Department, and Putrajaya Corporation. "Community mediation is an

effective way to resolve disputes in a peaceful and considerate manner, without having to go through complicated and

through complicated and time-consuming legal processes," National Unity Ministry secretary-general Datuk Seri Hasnol Zam Zam Ahmad said at the opening of the centre.

Also present were JPNIN director-general Datuk Che Roslan Che Daud, Putrajaya Corporation president Datuk Fadlun Mak Ujud and Putrajaya district police chief Asst Comm Aidi Sham Mohamed.

For Khairul Salleh Hasan, becoming a mediator was a nat-ural next step for him after being involved in his Kampung Malaysia Raya community in Kuala Lumpur for over 30 years

"I have undergone several
types of mediation training
which featured the use of sociology, psychology and communica
tions," said the 58-year-old who
has been involved in mediation
since 2010

since 2010.

"As one of the mediators attached to Kuala Lumpur City Hall's PMK, I also mediate neighbours' disputes such as those involving pets, parking spaces, physical obstructions and other arguments.

"Our team of five mediators has settled about 90% of the estimated 2,500 cases since the KL centre was set up in 2018." he

centre was set up in 2018," he

Khairul Salleh said a mediator has to be patient, fair and

impartial.
"A mediator cannot give advice and opinions, or make the decision.

"We ask open questions and try to generate options.
"The affected parties can decide on one of these options o come up with different ones, but they must have their own solu-

they must have their own solu-tions," he said.

Menteri di Jabatan Perdana Menteri (Undang-undang dan Reformasi Institusi), Datuk Seri Azalina Othman Said berkata, inisiatif itu membantu memperkasakan ekonomi golongan muda.

Nurul Nadiah Universiti Tenaga Nasional, Kampus Sultan Haji Ahmad Shah, Pahang Pertambahan populasi dunia dan perkembangan ekonomi pesat meningkatkan permintaan tenaga secara mendadak, terutama

dalam sektor pengangkutan.

Sektor ini kini menyumbang sekitar 16,2peratus daripada jumlah pelepasan karbon

kannya antara pengkat giobat, menjaar-kannya antara penyumbang utama kepada pencemaran udara dan perubahan iklim. Pada 2020 dan 2021, pelepasan karbon dioksida global melonjak sebanyak 7.0 peratus, mencapai 7.64 bilion tan akibat penggunaan tenaga dalam

sektor ini. Sejak 2016, perhatian utama beralih kepada tek-nologi kenderaan elektrik (EV) sebagai langkah-penting untuk mengurangkan pelepasan karbon dan meningkatkan kualiti udara.

Penggunaan EV dijangka meningkat dengan ke-tara antara 2030 hingga 2045, seterusnya memper-cepatkan usaha dekarbonisasi dalam sektor pe-ngangkutan dan menyokong matlamat kelestarian

Di Malaysia, penggunaan kenderaan EV semakin mendapat perhatian dengan pelbagai strategi dan sokongan kerajaan. Call for stricter monitoring of food handlers

Experts urge mandatory typhoid vaccination and display of health certificates to protect consumers

PETALING JAYA: With a stream of viral videos PETALING JAYA: With a stream of viral videos on social media platforms showing unhygienic practices among food handlers, experts are calling for strict monitoring to ensure they have been vaccinated against typhoid and display a health certificate as proof of compliance.

Universiti Putra Malaysia department of food service and management food safety expert Dr Noor Azira Abdul Mutalib said selling dirty or contaminated food not only endangers consumer health but also compromises business integrity.

"Earning money from unsafe food practices is dishonest and unethical as they should know their responsibility to serve safe and clean dishes to customers."

is dishonest and unethical as they should know their responsibility to serve safe and clean dishes to customers."

Noor Azira said under the Food Hygiene Regulations 2009, enforced by the Health Ministry, it is mandatory for all food handlers, including street vendors and those at hospitals, schools and even home-based ones, to be vaccinated against typhoid.

She said typhoid vaccines prevent contracting the fever caused by Salmonella Typhi (S. Typhi), a bacterium that some food handlers, who come into contact with food, water and utensils, may carry.

"Food handlers may have the bacterium without showing symptoms of foodborne illnesses, but they can still transmit S. Typhi to food, potentially causing consumers to be poisoned. Getting vaccinated also reduces the risk of contracting the bacterium from other sources."

Noor Azira said displaying proof of vaccination would enhance customer confidence and trust, assuring them that the food is clean and safe.

The type of proof varies depending on the clinic, with most issuing a small hooklet.

The type of proof varies depending on the clinic, with most issuing a small booklet containing details such as the recipient's name, identity card number and vaccination date.

"The authorities could also issue special badges to vaccinated food handlers to further instill consumer trust," she said, adding that

while the typhoid vaccine should be taken every three years, some individuals fail to get re-vaccinated when necessary.

Some food handlers who have never experienced serious illness may believe they are healthy and do not need the vaccine.

"While monitoring food handlers is challenging, efforts should include making vaccination a requirement for licence applications and authorities must frequently conduct random checks at food premises, rather than only responding to complaints," she said.

said.

Universiti Kebangsaan Malaysia Public Health Medicine specialist Prof Dr Sharifa Ezat Wan Puteh estimated that about 20% of food handlers in Malaysia might not have taken the typhoid vaccine, particularly food peddlers who operate without proper licensing.

"With the current financial struggles, many have turned to selling food and drinks, sometimes using semi-boiled or unboiled water to cut costs. Their items are sold in unhygienic conditions, which is heartbreaking, but desperation drives them to do it."

Sharifa Ezat said typhoid is a potentially

life-threatening disease that requires prompt treatment with antibiotics. S. Typhi can persist in a person's gallbladder

S. Typhi can persist in a person's gallbladder without causing symptoms, making the individual a chronic carrier and remaining contagious even after recovering.

"This is why food handlers are especially encouraged to get vaccinated because their role involves frequent contact with food and utensils, which increases the risk of spreading the bacteria. Children are particularly vulnerable."

Sharifa Ezat said untreated typhoid can lead to serious complications such as internal bleeding, intestinal perforation, a swollen or ruptured gallbladder, brain swelling, respiratory

problems or bone inflammation.

Other severe outcomes include heart inflammation, kidney failure and miscarriage, which is why the typhoid vaccine should never be regarded as trivial and unimportant.

She added that the vaccine is available for free at all government health clinics, while private healthcare providers typically charge RM60 to RM100 for the injectable form and RM50 to RM60 for the pill form.

"In the health aspect, Selangor Health Department will lead the health recovery programme with the aid of specialists from different fields," he said in a press conference after the mock cheque donation presentation at Bangunan Dewan Negeri Selangor in Shah Alam during break time from the state assembly sitting.



A total of 264 children from GISB are currently being cared for at JKM's shelter home in Selangor,

According to Amirudin, intensive screening and examinations carried out from Nov 4 to 8 on the affected children found

the affected children found 26.8% of them stunted and 6.8% severely stunted.

"After two months in the care of JKM, 38.6% of the children showed weight gain while 22% of them aged a few months to six years have speech problems.

"The mental health screening found 84.8% experiencing

found 84.8% experiencing

depression and 96.7% having

anxiety."
Amirudin said those who required further intervention for mild and moderate categories

would be referred to counsellors or clinical psychologists. He added that education recov-ery programmes had been con-ducted since Oct 1, including aca-demic and faith recovery.
