4.16% ratepayers object to Klang assessment rate hike

payers submitted objections to Klang Royal City Council (MBDK) against the proposed 25% assess-ment tax rate hike expected to

ment tax rate hike expected to take effect from January. Corporate Communications Department director Norfiza Mahfiz said MBDK stopped accepting objections on July 16. The objections had been received online and through

counters at the city council's headquarters in Lorong Perbandaran.

It is learnt that about 3,600 ratepayers had filed their objections online.

"Owners of residential properties submitted most of the objections," Norfiza said.

In June, MBDK sent notices of the proposed assessment tax rate hike to 268,445 property owners in Klang.

Norfiza said MBDK would hold objection hearings at Dewan

Hamzah opposite the city coun-

Hamzah opposite the city council's headquarters in stages for a month beginning next week.

"Property owners who submitted objections will be notified via email, WhatsApp or by post to attend hearing sessions."

Norfiza said once the hearing sessions are completed, constructive objections would be brought to a committee before the Selangor government makes a Selangor government makes a decision in September on wheth-er the new valuation would be enforced from Jan 1, 2025.

Klang mayor Datin Paduka Noraini Roslan said the council's last assessment review had been

conducted in 1993.

She said the cost of providing basic services like cutting grass, cleaning drains and collecting domestic waste had increased threefold.

threefold.
On May 30, Selangor Mentri
Besar Datuk Seri Amirudin Shari
said the new valuation process
carried out by the local authorities was important to ensure effective urban planning.

MBDK tows illegally parked heavy vehicles

HEAVY vehicles such as buses and lorries parked in residential areas or in a haphazard manner along main Klang roads are being towed.

Klang Royal City Council (MBDK) Corporate
Communications Department director Norfiza Mahfiz said three heavy vehicles were towed on July 18 with the cooperation of the South Klang Police Headquarters and Road

Transport Department (JPJ).

"None of the owners have claimed their vehicles yet.

"If these owners do claim the vehicles from the council's yard, they would have to pay compounds, towing costs and storage fees," she said.

Norfiza reminded vehicle owners to park in designated areas and not residential areas.

"The council has been getting complaints from residents

about this practice, which causes obstructions and affects the visibility of oncoming vehicles," she said.

Norfiza added that heavy vehicles parked on road shoulders overnight could also damage roads and drainage due to their weight.

"Our enforcement officers will be monitoring the situation and taking action against offenders," she said.

MPAJ intends to leverage on Visit Selangor Year 2025 and Visit Malaysia Year 2026 to draw tourists

WITH nearly half its area being forest reserves, Ampang Jaya has massive tourism potential which the local government intends to

capitalise on.
Ampang Jaya Municipal
Council (MPAJ) is embarking on
an ambitious plan to make it into
a tourism hotspot over the next

Its president Dr Ani Ahmad said they planned to boost the council's non-tax revenue by

council's non-tax revenue by drawing more tourists and visitors to Ampang Jaya.

While budget constraints are a hurdle, Ani is hopeful that a multi-phase rollout will allow for steady progress and successful completion of these tourism projects.

Several projects are already in the works while others are con-

MPAJ wants them all completed within the next five to 10 years. The council's efforts align with preparations for Visit Selangor ear 2025 and Visit Malaysia Year

Both are expected to draw around eight million visitors to Selangor.

The state government, as noted by Selangor housing and culture chairman Borhan Aman Shah, is committed to leveraging the tour-

committed to leveraging the tour-ism potential of each district, emphasising their specialties. Ani said MPAJ's proposed pro-jects had been presented to tour-ism and state authorities, to trans-form Ampang into a thriving tourism hub.

Taking in city views

Popular lookout spots to take in views of Kuala Lumpur are already attractions in MPAJ is hoping to further develop these lookout points in Bukit Antarabangsa and Bukit Ampang into safer, well-maintained recreational areas to draw in even more visitors.

in even more visitors.

These sites will have amenities like viewing platforms, seating and parking facilities to enhance visitor experience.

Ani said that plans for Bukit Ampang included building a viewing deck, landmark sculpture and soft landscaping.

"It is already an attraction as visitors are known to come here

"It is already an attraction as visitors are known to come here to take in the view.
"There used to be illegal stalls operating at the location.
"We could not legalise them as it was not safe.
"We can, however, turn the spot into a safe viewing location and this way neonle can still and this way, people can still enjoy the views," she said, adding that the estimated cost for the project is RM3mil. The proposed site is a 1.82ha open space along Jalan Persiaran Saujana, located in the vicinity of the Hulu Langat forest reserve.

MPAJ, Ani said, is hoping to capitalise on the ecotourism benefits of the popular recreational area with the proposed project.

Another location that MPAJ has already started turning into a lookout point is Panorama @

Bukit Antarabangsa.

The site, which is where the December 2008 landslide happened, has been turned into a recreation area and is a go-to location for visitors to enjoy the

MPAJ is in the midst of prepar-ing proper parking facilities to make it easier for visitors to access the site, along with pathways and seating areas to enhance the overall experience.

"We have allocated RM500,000

for the parking, drainage and other upgrades.

"We may have to charge a reasonable amount for parking to cover maintenance costs and ensure the continued upkeep of the facilities," Ani said, adding that the council was proposing to have installations to draw photo enthusiasts.

Popular murals

Colourfully painted walls continue to be a major draw for visitors, ranging from local art enthusiasts and photographers to tourists looking for unique and vibrant backgrounds for their photographer.

vibrant backgrounds for their photos. In 2019, MPAJ spent about RM1mil to upgrade and paint several murals near Ampang Point in Taman Dato Ahmad Razali. Phase One of the project, called the Senario Ampang lane, has 3D murals featuring vignettes of attractions as well as landmarks of the area. of the area.

Subsequent phases incorporated the 17 goals highlighted in the United Nations' Sustainable Development Goals (SDG) in

pictorial format.

The area is now known as Uptown Lorong Ampang

Mampan.

It was meant to revive the once dirty and dingy back lanes and make the area a more lively place for people to gather.

MPAJ is hoping that these visually striking murals can serve as a focal point for community events and social media engagement, revitalising public spaces and boosting foot traffic in the area.

area.

Besides the murals, retiling and repaving of walkways as well as drainage upgrading were also carried out at Jalan Mamanda 2

carried out at Jalan Mamanda 2 and Jalan Mamanda 7. Ani said MPAJ was hoping a night bazaar would bring in more visitors to the area.

visitors to the area.

"This would also help develop and boost tourism, including small and medium-scale industries," she said, adding this would help popularise murals painted on the walls of buildings around this commercial area.

She said that MPAJ was cur-



rently looking for organisers that would be able to run the bazaar. Further upgrading works that have been planned for the area include road repaving, installing a roof over the bazaar site, and repainting of faded murals.

At an alley off Jalan Negara in Taman Melawati, the plan is to develop an art-centric destination

develop an art-centric destination which already houses an art gallery, stationery shops, cafes and more murals and street art.

"With the variety of businesses here we can develop it as an art tourism destination, which would be known as Jalan Negara Kita,' said Ani.

She said this could also serve she said this could also serve as a location for mural artists, musicians and the community to gather, alongside hosting art exhibitions.

Promoting ecotourism

S'gor to set up hubs for healthy eating

Exco: All 56 constituencies to address developmental issues among children

HUBS to promote healthy eating habits among children and address child growth and development issues will be set up in all nine districts in Selangor, says Jamaliah Jamaluddin.

The state public health and environment committee chairman said as an expansion of

environment committee chair-man said as an expansion of the "Anak Selangor Anak Sihat" (Asas) programme, these centres would serve as screening and information hubs to educate the public on nutrition and

the public on nutrition and wellness.

Depending on results of the screening, the children would be provided with food baskets to suit their intake needs.

She said that the hubs would be located in all 56 assemblymen's service centres.

be located in all 56 assembly-men's service centres.

"The first step is to offer free health screenings for children to determine their nutritional sta-tus and identify any growth and development issues early on.

"With the information, our experts and volunteers will pro-vide personalised guidance and support to the children and their families.

families.
"These children will be moni-

tored for six months to chart any improvements," she said.

Jamaliah said the objective

was to provide early interven-tion for malnutrition and obesity issues among children.

To facilitate this, she said

The aim was to have 500 chil-dren screened at each location

dren screened at each location, she said.

"At the moment, we have little data on the number of children who are affected by these issues, "These (screenings) will allow us to obtain the necessary information, (when) done systematically and efficients," show

tematically and efficiently," sh said after launching the "Mini Fiesta Saringan Asas Kanak

Kanak" at Taman Muda commu-

nity hall in Ampang.

At the event, information on each participating child's age, weight and height was gathered and recorded.

"Karnival Asas is a continua-

tion of a previous programme where we provided nutritious food packages directly to select-ed individuals.

ed individuals.

"However, we could only target a limited number of children and it was not enough to make a significant impact; hence the carnival and hubs," she said.

Jamaliah said the state had allocated RM700,000 to carry out Asse programmes this year.

Asas programmes this year. The Asas programme started

No RON95 subsidy rationalisation for now, says Anwar %如

KUALA LUMPUR: The rationalisation of RON95 subsidy remains off the table for now, as the government wants to ensure the public fully understands the implementation of targeted diesel subsidies, says Datuk Seri Anwar Ibrahim.

"The matter has not been diesely and the same table of t

Ibrahim.

"The matter has not been discussed. We will deal with the diesel issue first, to give better and the right explanation.

"This is necessary because sometimes, certain parties will

spin the issue," he told reporters on the sidelines of the National Tax Conference 2024 yesterday. The Prime Minister said ration-alisation of fuel subsidies was necessary to balance the need between increasing government revenue and paying off national debt

debt.

Explaining further, Anwar, who is also Finance Minister, said various measures were being taken to boost government revenue, including prudent

spending and borrowing only when necessary for development purposes.

He said rationalisation of subsidies was a comprehensive effort and initiative covering a broader spectrum to help reduce the government's yearly borrowings.

"Other efforts include more efficient manner of enforcing the law and taxation efforts.

"If we don't do it, our revenue will not increase, but our debt will continue to rise," he said.

In May, Anwar announced the rationalisation of diesel subsidies for Peninsular Malaysia, which took effect on June 10.

Sabah and Sarawak are not effected by the move and the price remains at the subsidised rate of RM2.15.

To prevent drastic increases in the cost of goods and services, subsidies are given to traders using diesel-powered commercial vehicles.

This involves 10 public trans-

This involves 10 public trans-

portation vehicles and 23 goods transport vehicles.
Eligible groups such as private diesel vehicle owners, farmers and smallholders can apply for a RM200 monthly cash subsidy under the Budi Madani initiative.



'National debt to go down to RM86bil'

PM: Short-term measure needed to boost M'sia's financial capacity and stability

KUALA LUMPUR: Malaysia aiming to reduce its national debt to RM86bil this year as a shortterm measure to boost its finan-cial capacity and stability, says Datuk Seri Anwar Ibrahim. The Prime Minister said in 2021

and 2022, the country's borrowing stood at RM100bil before it was gradually reduced.
"The amount was reduced to RM93bil in 2023 and we aim to further reduce it to RM86bil this

year.
"However, we need to further reduce it, and if it is done drasti-cally, we cannot continue with our development agenda," he said in his opening speech at the National Tax Conference 2024 at the Kuala Lumpur Convention

the Kuala Lumpur Convention Centre yesterday.

Also present were Deputy Finance Minister Lim Hui Ying and Inland Revenue Board (LHDN) chief executive officer Datuk Dr Abu Tariq Jamaluddin.

Anwar said the government was taking prudent steps and stressed the importance of plug-ging potential financial leakages.



Citing the payment of RM48bil in debts incurred by 1Malaysia Development Bhd last year as an example, he said the money could have been better used for other purposes to benefit the people.

"Imagine if we can spend the RM48bil for the development of schools clinics, universities and

schools, clinics, universities and

PETALING JAYA: To better address future cyberbullying cases, laws have to be amended and social media platforms have to be regulated to keep up with the constantly evolving digital trends, says cybersecurity and multime-

says cybersecurity and multime-dia laws expert Derek Fernandez. According to Fernandez, present penalties under the Communications and Multimedia Act (CMA) 1998 are not adequate to punish bullies who digitally har-

ass people and therefore, amend-ments are necessary to substan-tially enhance its penalties.

He said the Penal Code should be amended to ensure that cyber-bullying would be addressed the

same as physical bullying,
"This will reduce the gap
between offences being committed in the virtual world and in the

red in the virtual world and in the non-virtual one," he said. Fernandez said the Penal Code was amended last year to include a newly-introduced Section 507A

to make stalking a crime.
"So, a general amendment can
also be made to include online conduct that causes an offence under the Penal Code, where such conduct can be committed through digital communication.

"This can be done together with the much-needed amendments to the CMA to provide a measure of regulatory protection against such

regulatory protection against such serious threats and abuse of online facilities," he said.

At the same time, Fernandez said it was important that overthe-top (OTT) platforms that profited from hosting social media content, to be under a legal duty to take immediate, effective and proactive definable steps to prevent or combat cyberbullying and scams.

"We have seen how in extreme cases, cyberbullying can cause self-harm, mental or physical injury and death.

"It is essential that all OTT plat-

forms be legally regulated so that they are under a legal obligation to take action promptly and effec-tively against persons whom they allow on their platforms – through whom they profit from the monet-isation of their data – from harm-ing, bullying and cheating other users of the platform and mem-

users of the platform and mem-bers of the public.
"This is especially so when pub-lic complaints to them about some-one feeling bullied, are ignored or dismissed or not attended to promptly," said Fernandez.

He said OTT platforms should have better measures to identify and ban cyberbullies from open-ing fresh accounts to continue bul-

ing fresh accounts to continue hullying victims after being blocked or removed.

"Regulating these platforms through legal licensing or clear laws and legal liability will ensure Malaysian online users have the same legal protection as those in the European Union, the United States and several other countries.

"This in turn will lead to more resources being invested by those

resources being invested by those who profit the most from these platforms, to seriously combat cyberbullying and other online harms," he said.

Lawyer Rajesh Nagarajan said provisions under Section 507 of the Penal Code penalised those who harass others with an intention to cause distress, fear or alarm to another person's safety.

"Under Section 507A, whoever repeatedly commits any act of harassment, intending to cause or

assment, intending to cause or knowing that it is likely to cause distress, fear or alarm to a person for his or her safety, commits the offence of stalking. "Penalties under Section 507A of the Penal Code include imprison-

ment for a term that may be extended to three years, or a fine,

or both.
"It is clear that the provisions are worded very widely to capture

any form of harassment and as

any form of harassment and as such, cyberstalking and online harassment would be covered too," added Rajesh.

Prof Dr Mohamed Ridza Wahiddin, founder and patron of International Islamic University Malaysia's Centre of Excellence for Cyber Security, said the current trends of cybersecurity threats included social engineering, cloud vulnerabilities, third party exposure, ransomware and attacks on internet of things (IoT) devices.

According to him, future proofing cybersecurity entails keeping up with a variety of new threats, legislation, conducting assurance reviews, and acknowledging the complexity of the IT reality.

"Clearly, in order to ensure our cybersecurity laws are future-proof, all the above factors should be taken into account.

"Furthermore, AI is only one of the many IT tools used for cybersecurity."

"This year, it is projected to de-

cent.
"To achieve that, the country needs to be managed well. There must be no leakages or misap-

must be no leakages or misap-propriation, or the rakyat and the country will suffer."

He said the government was committed to lowering the na-tional debt from 64 per cent to 60 per cent of the GDP.

He added that the money bor-rowed to settle previous debts constituted the biggest burden on the government.

A source said the suspects in the latest arrest, in their 30s and 40s, were held in Kuala Lumpur between 8.30am and 11am.

The source said about RM40,000 in cash was seized.
In one of the raids, two suspects

2.4 million drivers potential road bullies: Survey

PETALING JAYA: A Malaysian Institute of Road Safety Research survey has estimated that 2.4 million of the 13.3 million registered motorists in the country exhibit "furious anger" while driving.

He said road bullying may stem from various factors, such as stress, impatience, cultural attitudes towards driving and a lack of enforcement of traffic laws.

In Malaysia, congested roads, aggressive driving and a lack of consequences contribute to increasing road rage incidents.

He said Malaysians become easily stressed and angry on the road, especially during traffic congestions, with some drivers resorting to yelling, excessive

honking, throwing objects, tailgating, blocking, ramming or using foul language.

One road rage victim said she saw a motorist bullying female drivers near her workplace in Taman Sri Muda.

"Many victims, including those who work at nearby industrial areas, have lodged complaints through the e-Aduan@JPJ app. However, the bully is still on the road, targeting different victims daily. It seems reporting to authorities is pointless."

reporting to authorities is pointless."

Law said in such cases, offenders might perceive the penalties as minimal or unlikely to be enforced,

which could encourage them to continue their aggressive behaviour.

"A lack of stringent enforcement undermines the effectiveness of laws and regulations designed to address road bullying and road rage."

He said some countries have implemented severe penalties, such as heavy fines, suspension or revocation of driving licences, mandatory anger management courses or imprisonment.

"In Singapore, aggressive driving could lead to fines, imprisonment, or both. Such measures aim to send a strong message and have shown varying degrees of success in curbing road bullying."

He said enhancing enforcement could involve deploying more traffic police, using technology for monitoring and evidence collection and ensuring penalties escalate for repeat offenders.

"The situation has led to a persistent call for the governments."

ne situation has led to a persistent call for the government to introduce mandatory punishments, educational programmes and traditional fines. There are road safety advocates who argue that while fines are a deterrent, they are not always effective in changing behaviour.

"Mandatory punishments could provide substantial consequences

Mandatory punishments could provide substantial consequences for offenders. Programmes aimed at raising awareness about the dangers of road rage and bullying could help address the root causes of aggressive driving."

Law advised road rage victims to prioritise their safety by avoiding confrontation, staying calm and not responding to aggressive gestures or provocation.

"They could document the incident with a dashcam, note down details and report the incident.
"Authorities should act swiftly based on evidence provided by victims. When evidence is lacking, traffic surveillance could offer crucial information and help law enforcement identify and prosecute offenders."
