DBKL orders operator to vacate govt land at Kepong roundabout

THE operator of premises housing heavy machinery which is illegally occupying government land in Kepong, Kuala Lumpur, has until May 25 to vacate.

The premises is located at the roundabout between Jalan Udang Kepai and Jalan Mergastua.

A Kuala Lumpur City Hall (DBKL) letter dated March 27 obtained by Star Metro said that the local authority urgently needed to use the site.

It stated that action would be taken upon deadline expiry and DBKL would bill the operator for any costs involved.

"Kuala Lumpur mayor Datuk Seri Kamarulzaman Mat Salleh will not be responsible for any property damage sustained during the operation," the statement added.

notice was issued on Jan 12 but the operator had failed to com-

ply.

Youngsters moving for better pay

Better connectivity and urban living causing more to move in or out of sub-districts

PETALING JAYA: Younger people moving in and out of states is why many towns in Malaysia saw big jumps in population over the past 10 years.

Based on available data, Mukim Pulai in Johor is the sub-district that saw the largest spike in population in the country.

From 360,000 residents in 2010, its population swelled by 40.1% to over 500,000 in 2020.

This means an extra 144,763 people are now living in the sub-district in Johor Baru, known to have urban developments and attractions like the Legoland Malaysia theme park.

Malaysia theme park.
This is based on the Population and Housing Census of Malaysia 2020 (MyCensus 2020) by the

2020 (MyCensus 2020) by the Statistics Department.

The census covered over 1,700 administrative areas nationwide, where most or 65.3% showed an increase in population.


Malaysian Research Institute on

Ageing (MyAgeing) senior research officer Chai Sen Tyng said the growth in population was mainly

due to the movement of younger people who flocked to places that offered better paying jobs. "Populations move out of an area when a district or sub-dis-trict's economic activities are


"When this happens, there is little prospect for a higher-educated younger population," he said, adding that youths also moved to locations with better connectivity

and urban living.
For Chai, it was not surprising that Mukim Pulai had become increasingly populated.

"With new roads and more

property developments, the sub-district has attracted younger

people to move there.
"This is a suburban area that includes Gelang Patah and Iskandar Puteri, and stretches all the way to Taman Perling on the northeast side and Skudai in the

also straddles the two Singapore causeway entry points between Johor Baru and Tuas," he

said of Pulai's strategic location.
The sub-district also now hosts most of the government administrative centres for Johor at Kota Iskandar, Chai added

In Peninsular Malaysia, the areas in the MyCensus 2020 were categorised as sub-districts known as mukim, bandar and pekan.

For Sabah, Sarawak and Labuan, the areas were divided into district and sub-district lev-

In Sabah, the district with the biggest population growth was Kota Kinabalu, which grew by 48,367 people.
As of 2020, a total of 500,425

As of 2020, a total of 500,425 people live there – a 10.7% increase from 452,058 in 2010. In Sarawak, the state capital of Kuching saw the highest population growth among the total 40 districts, charting a jump in population from 566,318 to 609,205. At the state's sub-district level, Padawan took the lead

Padawan took the lead.

With an area experiencing pop-ulation growth, it's only natural

"The first issue that should be addressed is the higher demand for public spaces and services," Chai said.

Examples of such services are public sanitation, garbage collec-tion, water supply, telecommuni-cations, transportation, parks, restaurants, shopping malls and childcare facilities.

"Bottlenecks happen when new populations move in and the traffic dispersion is poorly planned,"

In Peninsular Malaysia, the

mukim that saw the biggest drop in population was Mukim

in population was Mukim Keratong in Rompin, Pahang.
Its population shrunk from 55,042 people in 2010 to 42,951 in 2020, which is a drop of 22%.
As for Sabah, the Keningau district faced the biggest population decline, with the number of residents going down by 12.8%.
From 173,103 people, its population shrunk to 150,927, a drop of 22,176 residents.
In Sarawak, Sarikei saw its population downsize the most from 56,228 people in 2010 to 44,039 in 2020.

Among the sub-districts in the state, Debak in the Betong district experienced the largest drop in population from 10,276 to 7,907.

ACCORDING to the Malaysian Youth Mental Health Index 2023 (MyMHI'23), six in 10 Malaysian youths aged between 15 and 30 years experienced mild to severe depressive symptoms.

Family is the fundamental unit of society, and this is where young children can learn how to take care of their mental health. Parents can be positive role models in displaying good mental

health practices.
Children learn by example and model how their parents manage their emotions. By creating a safe space, and encouraging open discussion about their mind, feelings and behaviour, parents can promote help-seeking behaviour in their children, making it easier, for them to ask for support when required.
Children should also be encouraged to play with others as it cultivates social skills, which are important as they grow older.

older. I believe the Education and

Health ministries have mental health modules with topics such as problem-solving skills, resilience and stress management that should be included in our school syllabus.

We need to start creating awareness of mental health among our young ones now. We need to help them cultivate good mental health behaviours and practices. practices.

Vital to boost reader loyalty

It helps attract and increase readership, say news industry players

KUALA LUMPUR: Boosting read-er loyalty and focusing on niche markets are some ways for news organisations to move forward in increasing readership, instead of heavily relying on social media platforms, say news industry

platforms, say news industry players.

South China Morning Post digital editor Shea Driscoll said while all readers are equally important, the concept of loyalty becomes a very important aspect to attract readership.

"So we have developed our own scales for reader loyalty and if somebody's coming back to you five to 10 times a month, over multiple sessions, then they are a loyal or regular reader.

"We then have to shift our focus towards analysing just top-line

towards analysing just top-line traffic, which obviously remains traffic, which obviously remains important, but also to find what our loyal and regular readers are specifically reading," he said during the "Innovation in Newsrooms" plenary session at Digital Media Asia (DMA) 2024 here vesterday.

Digital Media Asia (DMA) 2024 here yesterday.

The session was moderated by Star Media Group (SMG) chief content officer Datin Paduka Esther Ng, who had asked about the importance of niche and general audiences in setting the direction of business models.

This 2024 edition of DMA, the premier event for the news media industry in the Asia-Pacific region, marks its 16th year with a two-day gathering in the Malaysian capital starting yesterday.

Organised by the World Association of News Publishers (WAN-IFRA), the event has been a pivotal platform for transforma-

pivotal platform for transforma-tion in the news media industry

since its inception in 2009. Meanwhile, Driscoll also noted

that it is important to know what members of the niche audience want as they have a different list of stories that they are interested

of stories that they are in.

"So it depends on your specific business model. If your business model is to have as much reading as possible and making money from ads, for example, then in which case go for it, but we find that we really need to cultivate our loyal and regular readers," he explained.

explained. Veslemoy Ostrem, editor-inchief of Altinget Norway, a Nordic Media house that covers national and European politics, said that based on her personal experience, it is important to utilise user data to develop new areas of jour-

"We have a very successful project on the topic of leadership and careers, and how to have a good job.

"We have one journalist, and got over 1,000 new subscriptions ust from her stories, and that was

"She was inspired to see if she wrote the story in a slightly different way, would it attract more readers, would it just focus on her current ones, who were (her) loyal readers?" she said.

Asked about her views on how many madia companies continuation.

many media companies contin-

ued to rely on social media platforms to drive traffic to their sites and how to pivot from it, Ostrem said that perhaps news organisations can find new and innovative ways to attract readership and traffic to their sites.

"Of course, every reader is important, and the social media reader is a good reader," she said, adding that media organisations should find strategic ways to thange readers' habits and not focus purely on social media.

She also believes that loyal readers are much more valuable than regular visitors and they

than regular visitors and they can become "huge supporters of your organisation".

There are economic benefits from waste

LANDFILLS are supposed to be areas designated for wastes to be properly managed. They should be designed and operated according to accepted environmental standards.

standards.

The dumping of tonnes of expired rice and other foodstuff in a garbage disposal site recently clearly shows there is still lack of public understanding about the true purpose of landfills.

That episode was shocking not only because white rice, a precious commodity, was simply thrown away but also because it involved disposal by burning.

Open burning is clearly an offence in this country under Section 29A of the Environmental Quality Act 1974, and those convicted can be fined up to RM500,000 or jailed up to five years or both.

Moreover, this incident hap-

years or both.

Moreover, this incident happened at a time when the country was struggling with problems in the supply of white rice.

The rice may have been past its expiry date, but it still has value, hence it should not have been treated as waste.

treated as waste.
In many countries, rice that has



reached its expiry date is used as animal feed. In some countries, it is used as feed material for etha-

nol production.

Our problem is that we still do not have the right ecosystem to drive a circular economy where expired resources can be put to good use.

good use.
Experts agree that there are many economic opportunities to be derived from a circular economy, which promotes responsible consumption and production practices by adopting principles

such as reducing by design and value retention (by recycling, reusing, re-purposing) as well as extending the life cycle of prod-

victs.

Nowadays, doing business that benefits the environment attracts a lot of investment as well. This is also the reason why interest in ESG (environmental, social and governance) aspects has picked up momentum among companies and corporations worldwide. It is unfortunate that some

companies still do not understand

the benefits to be derived from investing in ESG.

Lately, there have been concerns over the dumping of palm oil empty fruit bunches (EFB) in landfills. This action is not only an environmental hazard but also a missed economic opportunity. It is an environmental hazard because, in a poorly designed and inadequately managed landfill, it will result in the emission of methane, which contributes to climate change.

metnane, which contributes to cli-mate change.

It is also a missed economic opportunity because there are many potential products that can be generated from the cellulose and fibre of the empty bunches.

Poor awareness of the true functions of landfills has led to much abuse of these wasted dis

nunctions of landfills has led to much abuse of these waste disposal facilities.

The sad part is that the country is missing out on the opportunity to create economic value from waste

Climate's effects on work

THIS year's theme for World Day for Safety and Health at Work,
"Impact of climate change on
occupational safety and health",
couldn't be more relevant for Malaysia. The recent, record-breaking

Malaysia.

The recent, record-breaking storm and flooding in Dubai, a region not typically associated with such weather extremes, serves as a stark reminder that no country is safe from the impacts of climate change.

Climate change is reshaping the landscape of Malaysian workplaces in various ways.

1. Extreme weather: More frequent and intense storms, floods, and landslides disrupt operations, damage infrastructure and endanger workers, especially in vulnerable areas like construction sites and coastal regions.

2. Heat stress: Rising temperatures due to global warming exacerbate heat waves, posing significant health risks to outdoor workers, construction crews, agricultural workers and those in environments without

proper air cooling systems.

3. Disrupted supply chains:
Extreme weather events can disrupt supply chains, impacting the transport of raw materials, production schedules and, ultimately, the livelihood of workers. This can lead to job insecurity and economic hardship.

4. Spread of disease: Changes in temperature and precipitation patterns can lead to the spread of vector-borne diseases such as dengue fever, West Nile virus and malaria. This creates health risks for workers and additional burdens on the healthcare system.

The dire situation demands that we take concrete steps to build climate-resilient workplaces and embrace sustainable prac-

tices.
This isn't just about protecting the environment; it's also about ensuring the well-being and safety of every worker in Malaysia.
A 2020 report by the Malaysia Science, Technology and Innovation Ministry (Mosti)

shows that Malaysians are highly concerned about pollution, but translating this concern into action requires leadership and a

translating this concern into action requires leadership and a clear plan.

Here's how I believe the various stakeholders can respond:

1. Science, Technology and Inmovation Ministry: It holds a pivotal position in driving forward the research and development of energy-efficient production processes within factories, aimed at significantly reducing carbon footprints. This ministry can also lead initiatives to minimise waste generation, reduce plastic usage, and mitigate air and water pollution.

2. Department of Occupational Safety and Health (DOSH): DOSH has a vital role in enforcing regulations related to climate risks like heat stress and pollution. Strengthening enforcement measures and ensuring compliance with environmental regulations is key to protecting workers and the environment.

3. Industry leaders: Businesses,

especially small and medium enterprises (SMEs), need to prioritise environmental, social and governance (ESG) compliance. Even small steps towards sustainability can make a significant difference. Not only will they protect the environment, but they will also enhance competitiveness in the global market.

4. Employees: Workers play an important role in ensuring their own safety and advocating for change in their workplaces. By staying informed about climaterisks and speaking up about safety concerns, they can contribute to creating safer and healthier work environments.

As we observe World Day for Safety and Health at Work on April 28, let's expand our definition of safety to include safeguarding our environment.

Riding for neighbourhood safety

SS14 residents' bicycle patrols continue to play part in community policing

BICYCLE patrols in SS14 Subang Jaya, Selangor, are a weekly sight as the residential area's Rukun Tetangga (RT) teams patrol the streets to

ensure safety.
The Cycle Ronda Team has resident-volunteers in two teams of four.

teams of four.

They play a crucial part in community policing to help keep the neighbourhood safe.

SS14 RT member Dr Chris-

topher Tan, who leads the bicycle patrol, said every Tuesday the team covered about 7km in about an hour starting

from 8.30pm.

from 8.30pm.

"Our team rides through the residential areas, along shop lots, back lanes and the main road of Jalan SS14/1 where the LRT SS18 station borders SS14.

"We go past the LRT station to keep watch for office workers walking home.

"While on patrol, if our team spots any suspicious characters seated in cars with engines idling, we will approach and ask if they need directions.

"This usually prompts them to drive away. If the vehicle is still in the area, we will call the police," he said.

be closer to the people they

were watching out for.

Being on bikes also gave better access into several parks in the area and encouraged conversation with residents, he

"Our SS14 RT wants to create

"Our SS14 RT wants to create a connection with the people so that if something were to occur, they will tell us as they know who we are," he said.

Victor Choo, who founded the bicycle patrol in 2018, is glad that the patrols are still being carried out as the aim is to create visibility and to respond promptly to residents' needs. promptly to residents' needs. SS14 RT chairman John

Zachariah said the area was

sandwiched between New Pantai Expressway (NPE) to the north, Shah Alam Express-way (Kesas) to the south, Persia-

way (Kesas) to the south, Persiaran Kewajipan to the east and Persiaran Jengka to the west.
"Our neighbourhood is well-planned as the roads are mostly laid out in a grid with properties facing north-south or east-west.
"The area comprises mostly residential properties with several rows of shoplots fronting main roads and three schools," he said.

"Namun, teknologi Generative AI (GAI) boleh mempercepatkan proses pembelajaran kerana idea-idea baharu dapat dijana dengan mudah dan GAI berfungsi sebagai sumber rujukan terkini.

"Masa pembelajaran juga dapat disingkatkan. Bagaimanapun, cara Al diguna pakai perlu dilihat secara menyeluruh kerana sistemnya yang belum cukup efisien," katanya kepada Sinar Premium.

Ujarnya, antara kelemahan Al dari segi pendidikan adalah apabila pelajar bergantung kepada teknologi tersebut untuk mendapatkan jawapan dalam menyelesalkan sesuatu masalah.

Tambahnya, untuk memastikan pelajaran yang menggunakan teknologi Al dapat dipakai secara bertanggungjawab, pelajar perlu memahami serta mematuhi etika penggunaan aplikasi Al dengan betul terutama dalam peringkat penilaian seperti ujian dan tugasan.

"Pastikan setiap maklumat diperoleh Al disemak sumbernya kembali. Pelajar perlu bersedia untuk berkongsi maklumat yang dijanakan oleh Al kepada pensyarah terutama dalam menyiapkan tugasan yang menggunakan Al.

"Banyak pihak seperti institusi pendidikan tinggi dan teknikal dengan kolaborasi industri berlumba-lumba untuk menjadi juara dalam bi-

dang Al. Apa yang diperlukan adalah lebih banyak program seperti Robotik dan Al programming kerana terdapat peluang kerjaya yang baharu dalam bidang ini.

"Al juga harus dimanfaatkan sebagai pemacu inovasi dan kreativiti kerana ia menjimatkan masa dalam penyelidikan

Menurut felo penyelidik di Institut Kajian Malaysia dan Antarabangsa (IKMAS), Universiti Kebangsaan Malaysia itu, inisiatif tersebut tidak akan memberi kesan kepada simpanan masa tua sekiranya ahli KWSP tidak mengeluarkan simpanan dan mendapat gaji yang lebih tinggi sepanjang tempoh bekerja. Ujarnya, pencarum atau ahli aktif akan bersara dan mem-

punyai tahap simpanan asas di-jangka meningkat kepada 65 peratus pada tahun 2035 ber-banding 33.1 peratus sebelum ini (2023), "Namun, jika ramai yang membuat pengeluaran tetapi gaji

masih kecil, ramai yang akan bersara dalam kemiskinan. "Kini, hampir separuh daripa-da 13 juta ahli KWSP mempunyai jumlah keseluruhan simpanan kurang daripada RM13,000 dan tidak mengejutkan, kaum yang

mempunyai simpanan paling rendah adalah bumiputera," jelasnya. Muhammed ber-

kata, tindakan KWSP memperkenalkan Akaun 3 merupakan salah satu penyelesaian dalam menghadapi kemelut ke-hidupan yang dihadapi rakyat de-ngan tekanan kos hidup tinggi.

Katanya, walaupun pengeluaran simpanan hari tua bukan polisi terbaik tetapi buat masa ini, itu sahaja alternatif yang boleh diambil apabila bantuan lain tidak mencukupi. "Tambahan pula, sudah ada

Walaupun semua pekerja dilindungi di bawah KWSP namun jika pendapatan rendah, banyak pekerja akan bersara dalam kemiskinan. Gaji mesti di-naikkan, jika tidak lagi ramai orang tua akan hidup dalam ke-

miskinan," kata Muhammed.
Ujarnya, kemudahan Akaun
3 perlu fleksibel iaitu pencarum
boleh mengeluarkan simpanan
pada bila-bila masa dan dividen haruslah sama dengan simpan-an di akaun 1 dan 2.

"Apa yang lebih afdal, adil dan berkesan adalah kerajaan mengambil langkah proaktif untuk meningkatkan liputan serta kecukupan program bantuan tunai.

"Tanggungjawab itu terletak dalam bidang kuasa kerajaan dan bukannya KWSP sematamata," ulasnya.



EPF TO UNVEIL THIRD ACCOUNT FOR CONTRIBUTORS TODAY

It will offer members freedom to withdraw funds at any time

HE Employees Provident Fund (EPF) will antionunce the highly anticipated Account 3 today, offering flexibility to contributors in managing their savings.

It is learnt that a key feature of

It is learnt that a key feature of Account 3 is the freedom to opt in

or opt out.

It is also understood that EPF members will be given a grace period to decide on the arrangement that will be made available to them starting today.

period to decide on the arrangement that will be made available to them, starting today.

Among the three EPF accounts, Account 1 — known as Akaun Persaraan — will be designated for retirement savings, while Account 2, referred to as Akaun Sejahtera, will cater to withdrawals for education, health and housing expenses.

Account 3, named Akaun Flek-

sibel, will serve as a reserve for emergencies.

Seventy per cent of EPF members' monthly contributions are channelled into Account 1, which cannot be accessed until after retirement.

The other 30 per cent goes into Account 2, which can be accessed to pay for education, healthcare

and housing, as well as a partial one-time withdrawal at age 50. From May, the restructured system will see monthly contributions split three ways: 75 per cent will go into Account 1, 15 per cent into Account 2 and 10 per cent into Account 3.

Account 3 provides contributors with the flexibility to with-

draw funds at any time, similar to a savings account.

EPF is considering allowing members aiming to maximise capital gains to transfer funds from Account 3 to Account 2.

The introduction of Account 2.

The introduction of Account 3 comes after four Covid-19 pandemic-related withdrawal programmes, which drained RM145 billion from the EPF.

billion from the EPF.
As of December 2023, the pension fund's investment assets stood at RM1.13 trillion.

The New Straits Times recently reported that members who opt not to withdraw from Account 3 might receive a significantly lower "token" payout compared with the dividends for Accounts 1 and

The EPF paid out RM57.8 billion in dividend to members for 2023, comprising a 5.5 per cent dividend for members with the conventional account and 5.4 per cent for the syariah account.

It announced a dividend of 5.35 per cent for conventional accounts and 4.75 per cent for syariah accounts in 2022.

At the end of last year, the EPF had 8.5 million active members.

Of these, 6.7 million have conventional accounts, while the rest are syariah account holders.

The ministry also approved RM60.5 billion worth of digital investments in 2023.
From 2021 to 2023, the amount approved totaled RM44.7 billion, whereby data centres take up a lon's share of the total at RM144.7 billion.

"Based on discussions with companies, our export will go up as they build up capacity following the demand from various industries.

If we look at the investments made globally, this upcycle will benefit Malaysia."
Tengku Zafrul added that the ministry is concluding a free-trade agreement (FTA) with the United Arab Emirates by June.
He said it is the first FTA with the Middle Eastern country, adding that it is a comprehensive economic partnership agreement.

'Passport renewals can't be rejected solely for poor BM proficiency

KUALA LUMPUR: Immigration officers are not permitted to reject applications solely based on the applicant's proficiency in the national language, said Immigration director-general Datuk Ruslin Jusoh.

The department, he said, had looked into a report that a woman's passport renewal application was denied because she could not speak Malay properly.

The incident, which gained attention on social media, occurred at the Urban Transformation Centre (UTC) in Penang.

Ruslin said the woman in question had since been able to successfully renew her passport and collected it from the UTC Penang office on April 22.

However, he clarified that officers conducted random checks

He added that these checks were expected to be carried out in a professional and courteous

Ruslin also reiterated the de-partment's commitment to providing excellent customer ser-

vice.

He emphasised the importance of adhering to the standard operating procedure (SOP) set forth by the department.

It was reported earlier that the Penang Immigration Department was investigating claims that its personnel refused to renew the woman's passport.

"We are aware of the matter and an investigation is underway. Any statement will be shared later," a spokesman said when contacted.

The incident gained traction on Facebook on Saturday through a post attributed to the woman's son, following their visit to the UTC in Komtar.

In the post, the man claimed to have brought his parents to the Penang Immigration counter for passengt renewal and his father

Penang Immigration counter for passport renewal and his father had no issues.

However, the staff at the counter refused to renew his mother's document because she did not speak Malay.

The man also said that his mother could not speak Malay as she did not have the means to obtain education, but the staff insisted that she return on another day to meet with an officer.

A check on Facebook found that the post has been deleted, but can still be read on various pages.

THE ringgit closed marginally lower yesterday on firmer US dollar Index despite the sluggish US manufacturing Purchasing Managers' Index data yesterday.

At 6pm, the ringgit slightly eased to 4.7765/7780 against the

greenback from Tuesday's closing of 4.7785/7820.

Bank Muamalat Malaysia Bhd chief economist Mohd Afzanizam Abdul Rashid said the markets were wary of what the US Federal Reserve might utter next week during its Federal Open Market Committee (FOMC) meeting on April 30 to May 1.

'Hence, the US Personal Consumption Expenditures (PCE) inflation data scheduled to be released on April 26 will be closely

monitored," Mohd Afzanizam told Bernama.

He noted that the US PMI for manufacturing yesterday declined to below 50 points in April after remaining above 50 points in the past three months.

Meanwhile, SPI Asset Management managing director Stephen Innes said the PCE is considered the week's major macro event for investors.

It rose slightly vis-a-vis the Japanese yen to 3.0830/0840 from 3.0863/0887 at Tuesday's close, depreciated versus the British pound to 5.9362/9381 from 5.9067/9110 yesterday and slid against the euro to 5.1046/1062 from 5.0944/0981 previously.
