'Mindset of highrise management, residents key to meeting waste separation objectives'

SELANGOR is set to finalise the ratification of the Solid Waste and Public Cleansing Management Act 2007 (Act 672) by this year, paving the way for stricter regulations on waste management.

Once enforced, residents will be required by law to separate their waste into recyclables and non-recyclables or face penalties.

ALSO READ: Separation at source still a challenge in Kuala Lumpur

The move is part of a nationwide effort to standardise solid waste management and public cleansing laws, following the Cabinet's in-principle approval for Selangor to adopt Act 672.

Several local authorities including Petaling Jaya City Council (MBPJ), Subang Jaya City Council (MBSJ) and Ampang Jaya Municipal Council (MPAJ), have rolled out pilot projects to promote waste separation at source.

MBPJ's Door-to-Door Collection and Recycling Programme, which started as a pilot project in 2016, was officially rolled out in 2020.

Some 87,128 landed residential premises in Petaling Jaya are involved in recycling as of March last year.

In Subang Jaya, a door-to-door recyclable collection programme kicked off in December 2023 in SS12 to SS19.

It was expanded to USJ1 to USJ22 last year.

In Ampang Jaya, a key initiative - Recycling Initiative for Ampang Strata (ReFAST) - was launched in 2024 to encourage highrise residences to implement waste segregation.

Jointly spearheaded by MPAJ and Malaysian Recycling Alliance (Marea), the project has received mixed response from residents.

Marea project manager Alex Lim said the mindset and beliefs of officers within management bodies of highrises were critical factors influencing the response and success of ReFAST.

"This is instrumental in driving the success of recycling initiatives in the respective buildings.

During the implementation period, ReFAST successfully recovered between four and seven metric tonnes of dry-mixed recyclables each month.

"Recovering plastics is Marea's core focus and we successfully had a consistent collection of around 1,200kg of plastics a month," he said.

"This was not only an opportunity for residents to learn how to safely and responsibly manage their waste to enable recovery, it was also crucial learning for Marea in understanding societal behaviours and practices."

He added that through the initiative, 26 different materials including used cooking oil and e-waste were collected.

Lim said scaling up collection efforts would require clear targets and enforcement measures by the government.

One of the key challenges was developing an accurate reporting system to track recovered recyclables, he said.

"We had to rigorously track and trace the recyclables collected, and engage independent auditors to verify the numbers we report to our contributors.

"Challenges unique to the high-rise residences include infrastructural issues which prevent collection and storage.

"A key challenge was addressing the theft of recyclables.

"This was done through close collaboration with the cleaners in respective buildings regarding theft of recyclables, to prevent materials being diverted to other channels," he explained.

While Marea was able to implement temporary solutions to support collection efforts, Lim stressed that more investment was needed in high-rises to establish dedicated waste segregation and recycling areas.

Through ReFAST, a buy-back system was introduced to ensure all stakeholders involved in the collection process were compensated.

"Importantly, we ensured that the cleaners received monetary benefits for their cooperation in making this project a success.

"This work has also influenced us to look more into the support that must be provided to the informal waste workers, as they contribute to about 59% of global plastics recovered," said Lim.

At Oakleaf Park Condominium in Bukit Antarabangsa, Hulu Kelang, about 40% of residents have consistently participated in the recycling initiative over the past year.

Building manager Zulki Awal Ibrahim said residents separated recyclable and non-recyclable waste to make collection easier for cleaners.

"In the beginning, it took time for people to get used to the idea and practise waste separation.

"But participation has been consistent, and our cleaners ensure prompt collection," he said.

Zulki said proceeds from the sale of recyclables were shared with cleaners in a

"Over the past year we have collected about RM5,000 which has been used for minor repairs to the refuse room, including fixing the roof and shutters," he said.

#### Expansion in the works

MPAJ said almost 60,000kg of recyclables were collected from December 2023 to December 2024 under the ReFAST programme.

It added that the programme would be expanded to include three more highrises - Widuri Apartment in Taman Kosas, Nadayu62 and Nadayu63 in Taman Melawati - this year.

MPAJ, in a written reply to StarMetro, said there were several criteria for selecting stratified properties for the programme.

"Residents also play a major role in the programme by separating recyclable materials such as paper, plastic, aluminium and metal from domestic waste like food scraps, before disposing them into designated recycling bins.

"The building management must ensure that separate recycling bins are placed in strategic locations, particularly nearby the main waste disposal areas.

"A temporary collection centre should be made available to store recyclables before they are picked up (by the designated waste collectors)," MPAJ stated.

The local council has emphasised on the building management's responsibility in overseeing the programme.

"The joint management body (JMB) or management corporation (MC) have to actively implement and monitor recycling efforts within their respective buildings.

"They are also encouraged to conduct awareness campaigns."

According to MPAJ, the impact of the initiative was assessed based on several key indicators, including increased data collection on recycling activities and a reduction in landfill disposal costs.

"It has also benefitted residents and building managements financially by providing a platform for selling recyclables."

MPAJ said the ReFAST initiative was part of its broader efforts to promote environmental sustainability and support Selangor's goal of achieving a 15% recycling rate.

"By increasing the recycling rate, the volume of waste disposed at landfills can be cut by between 0.5% to 20% over the next few years," the council said.

"MPAJ's goal is to promote a circular economy by minimising waste and maximising the use of recyclable materials."

To achieve these targets, the council said effective waste management required community involvement.

It added that MPAJ planned to enhance recycling efforts through waste separation at the source, awareness campaigns, the adoption of advanced recycling technologies, and incentive programmes for both the public and industries.

### Green programmes

Besides the ReFAST programme, MPAJ has several other ongoing efforts geared towards environmental sustainability.

The "Trash to Cash" programme allows residents to exchange recyclables, used cooking oil, and e-waste for cash based on weight and market value.

This initiative, available at all 24 Residents' Committee (JKP) zones, takes place on weekends to maximise community participation.

Similarly, the Beverage Carton Collection Programme is being implemented at 14 cafes and restaurants in Pandan Indah and Ampang Point, in collaboration with Tetra Pak and KPT Recycle Sdn Bhd.

To further promote recycling at the source, MPAJ has introduced waste collection programmes in 11 residential areas, including Taman Melawati, Taman Riverview and Taman Saga.

Additionally, recycling cage collection points have been set up at eight locations. such as Pandan Indah Phase 2 and Ampang Hospital Quarters, to facilitate easy disposal of recyclables.

The local council has also partnered with Kloth Cares for a used clothing collection initiative to promote textile recycling.

# Separation at source still a challenge in Kuala Lumpur

GETTING highrise residents to separate their waste properly remains a major challenge although solid waste separation

attrough som waste separation at source is now mandatory in Kuala Lumpur. Federal Territories Solid Waste Management and Public Cleansing Corporation (SWCorp) chief executive officer Khalid chief executive officer Khalid.
Mohamed said while joint management bodies (JMB) and management committees (MC) were responsible for ensuring compliance, the diversity and dense population at such buildings complicated the effort.

"Not all residents understand

"Not all residents understand or consistently practise waste segregation at home.

"The role of the JMB or MC is to ensure residents dispose of waste at designated collection points according to correct waste categories.

"This means residents are required to segregate their

required to segregate their waste at home before bringing it down to the collection point," he said in a written reply to StarMetro. Khalid said SWCorp carried out regular enforcement at all

highrises in Kuala Lumpur. In 2024, a total of 469 JMBs or MCs overseeing stratified resi-dences in Kuala Lumpur were inspected.

inspected.
"During these inspections, the designated waste collection points within each stratified property were thoroughly assessed to ensure compliance with waste management

regulations.
"We also provide detailed explanations to JMBs and MCs about their responsibility in ensuring the separation of recy-clable waste and residual waste

clable waste and residual waste at designated collection points. "As of now, enforcement is targeted at landed premises in Kuala Lumpur. "No compounds have been issued to the JMB or MC of highrises," he said.

Since Sept 1, 2015, the government has made solid waste segregation at source mandatory, in line with the Solid Waste and regation at source manuatory, in line with the Solid Waste and Public Cleansing Management Act 2007 (Act 672). The Federal Territories of

Kuala Lumpur and Putrajaya are among states that have

adopted Act 672, along with Pahang, Johor, Melaka, Negri Sembilan, Perlis and Kedah.
According to SWCorp, implementation efforts were carried out in three phases.
Phase 1, from Aug 1 to Dec 31, 2016 – focused on notifying and engaging JMBs to ensure they understood the importance of separation at source.
Phase 2, from Jan 1 to June 30, 2017, introduced inspections

while engagement efforts continued.

continued.

These inspections, carried out using a separation-at-source implementation checklist for residential highrises, was for assessing compliance.

JMBs failing to implement solid waste segregation initiatives would receive warning letters.

Phase 3 began on July 1, 2017, marking the enforcement stage. Stricter actions were intro-

duced to ensure compliance with separation-at-source

with separation-al-source regulations. For highrise properties, Khalid said SWCorp had issued reminders to the JMB and MC to intensify engagement with residents to ensure proper waste segregation and to make it a

daily practice. "We have consistently carried out public awareness campaigns for various target group activi-ties including talks and exhibi-tions held both in and outside of

non-Act states." SWCorp has held 3,054 exhibi-tions and 5,369 talks nationwide since 2016, with 527 exhibitions

and 500 talks in 2024 regarding

SAS awareness. Khalid said SWCorp, through waste concessionaire Alam Flora, had provided two types of recycling collection facilities – dry-mix recyclables (DMR bins)

and recycling cages.
"A total of 105 DMR bins and 990 recycling cages have been placed in highrise buildings in

Putrajaya and Kuala Lumpur." To ensure recyclable waste in highrise residences do not get mixed with general waste, SWCorp has instructed conces-sionaires to place dedicated DMR bins near rubbish houses. "This makes it easier for resi-

dents to separate recyclables from regular rubbish.

"SWCorp also requires waste concessionaires to use dedicated vehicles for collecting recycla-bles so that the rubbish that residents have separated, doesn't end up in the landfill," he said. To keep things on track,

SWCorp carries out routine monitoring to ensure that contractors are not mixing recyclables with general waste.

### LDP flood mitigation project ready in May, says Subang Jaya mayor

THE flood mitigation project along Damansara-Puchong Highway (LDP) highway is in its final stages, with full completion expected in May.
Subang Jaya mayor Datuk Amirul Azizan Abd Rahim said the project, first announced on Nov 5, 2023, was about 85% complete.
Amirul Azizan was speaking at a press conference after chairing the Subang Jaya City Council (MBSJ) full board meeting. Initially slated for completion in 2024, the project was delayed

multiple times due to weather conditions and traffic manage-ment issues hindering the con-

tractor's work hours.

MBSJ Engineering Department director Dr Mohd Ariffuddin Kamari, who was at the press

Kamari, who was at the press conference, said he had visited the site to check on the progress. He said work on the pipe culverts, installed using jacking techniques across the LDP from Pusat Bandar Puchong to IOI Mall, was almost finished. The final step, he said, would be connecting the pipes. He added that the pipe realignment was part of measures to

ment was part of measures to upgrade the drainage system in both upstream and downstream

The RM5.7mil mitigation

project was mooted in response to a series of flash floods that caused significant damage, including submerging the carpark and lower floor of Puchong IOI Mall under 0.3m of

water.
The project cost is being borne by IOI Corporation Bhd, LDP highway concessionaire Litrak and the city council.
Amirul Azizan also highlighted the need for MBSJ to be on alert for flash floods as Malaysia was currently in the monsoon transition phase, expected to last until May.
This season typically brings strong winds and heavy rain in

short bursts, particularly in the late afternoon and early evening across numerous states including

However, the city council was allowing the operator to sort the existing waste as part of its efforts to support businesses that

recover valuable materials and minimise the amount of rubbish sent to landfills, she said.

Meanwhile, Norfiza said checks on a rubbish separation and sorting premises in Jalan Sungai Chandong, Bandar Armada Putra in Pulau Indah, found that it was operating without a licence.

"It is a repeat offender despite MBDK having previously taken action against the operator."

# 'Nab litterbugs before Visit Malaysia 2026'

PETALING JAYA: Establishing community service for serial litterbugs should be expedited, as it can help deter irresponsible dumping ahead of Visit Malaysia 2026, say groups.

Federation of Malaysian Consumers Association (Fomca) chief

executive officer Saravanan Thambirajah said delaying action may signal tolerance for behav-iour that affects the environment, public health, tourism and local government costs.

"However, fast-tracking the law should also be accompanied by robust public education and con-sultation to ensure it is accepted, understood and effectively imple-mented," he said.

The government tabled amendments to three acts related to public hygiene on March 5. government may soon order litterbugs to perform community service, and those who fail to comply will face a fine ranging from RM2,000 to RM10,000.

Saravanan said requiring litterbugs to perform community service, especially cleaning public spaces, is a constructive and educational approach.

"It serves as a deterrent and helps instil a sense of responsibi-lity and accountability among offenders.

"The visibility of such penalties particularly if special uniforms are worn – can serve as a power-ful public reminder that littering has real consequences," he said. However, he said enforcement

must be done transparently and without discrimination.

without discrimination.

"Authorities must avoid targeting only certain socio-economic groups or locations.

"Public awareness campaigns should clearly outline the laws and penalties to avoid ambiguity.

"There should also be provisions for appeals and community engagement so that the punishment fits the offence and is not considered overly punitive or considered overly punitive or stigmatising," he said, adding that uniform enforcement should be across urban and rural areas.

He said education and aware-ness must go hand in hand with

ronmental responsibility should be part of the curriculum. "Local councils and NGOs can collaborate to run anti-littering campaigns, provide adequate bins and recycling facilities, and organisa, community clean up.

bins and recycling facilities, and organise community clean-up events," he said.

He added that incentivising cleanliness – such as through competitions or rewards – can also foster positive behaviour.

"Ultimately, long-term change depends on shaping societal attitudes towards public hygiene and shared spaces," he said.

Consumers Association of Penang senior education officer NV Subbarow said proactive measures should be taken now to raise more awareness of the harms of littering before the law comes into force.

comes into force.

He said this includes having the He said this includes having the authorities play pre-recorded messages on loudspeakers during patrols to instil awareness of littering, similar to what was done when the smoking ban at restaurants came into effect in

Subbarow added that the process builds the authorities' omnipresence and reminds people to

discard waste correctly.

"Back then, the messages reminded people not to smoke in restaurants, but now it can be about not simply throwing waste. This can start at known littering hotspots or public areas. "We need to instil such habits in

"We need to instil such habits in fellow Malaysians ahead of Visit Malaysia 2026, as we don't want tourists to see rubbish all around," he pointed out.

He said the announcements could also prove more efficient at getting people's attention.

"Relevant enforcement officers can also add a human touch by reminding the public of proper waste disposal during their patrols on foot," he said.

He noted that community leaders can also play their part when meeting fellow residents.

"Community service for litterbugs is also timely. This will deter people from doing so, especially if

people from doing so, especially if the community service is highly publicised," Subbarow added. Radzuan Samsudin, deputy president of a resident group in Bandar Kinrara, Puchong, said the residential area he lives in

faces the problem of bulk waste dumping, including furniture, despite the local council putting up signboards warning residents against throwing out bulk items in the area.

"Introducing community ser-vice to the litterbugs would deter people from irresponsible dump-

"Those hearing of others having gone through such, community service would also be reminded that they too could face such action," Radzuan added.

Resident group president of Shah Alam Mushthaq Ahmad Ibrahim said the law should be enforced appropriately.

"This should also impact foreign workers and tourists, as in other developed countries," he said. He added that foreign workers

working at housing construction sites were contributing to the

"In areas with foreigners or low-income areas, rubbish is not being discarded properly.
"This causes the disposal area to become infested with rodents,

potentially causing harm to public health," he said.

On March 4, amendments to three Acts related to public hyglene were tabled for their first reading in the Dewan Rakyat.

- They are the:

  Local Government Act 1976
  Street, Drainage and Building Act 1974
  Solid Waste and Public Cleansing
  Management Act 2007



- Amendments allow the court to sentence a person convicted of offences under relevant sections to complete up to 12 hours of community service.
- It can be carried out up to four hours a day but must be completed within six months.
- Courts have to identify if the convicted person can perform community service based on their physical and mental condition.
- Once sentenced, a local authority official determines the type, time and place for the community service.
- Local authorities will be allowed to make by-laws to prescribe the type of community service performed.
- Any person failing to comply with the community service order face a fine of between RM2,000 and RM10,000.
- Offenders under 18 will be subjected to provisions under the Child Act 2001 related to community service orders.

## **Emphasise** education, not just punishment

PETALING JAYA: Education, and not just punishment, should be the objective of having serial litterbugs carry out community service, say environmental groups.

While welcoming the move, they said education should be carried out holistically at early education levels to ingrain the habit of keeping surroundings clean.

Sahabat Alam Malaysia honorary secretary Mageswari Sangaralingam said community service must take an educational approach towards the harms of littering.

"It should create a greater sense of responsibility towards both the environment and community.

Making community service "visible" will also reinforce the consequences of littering, she said when contacted.

She said installing surveillance cameras in identified hotspots can help detect perpetrators.

"The local authorities would be aware of these areas," she said, also mooting the establishment of public service hotlines to report littering.

"When there are tip-offs, local authorities and enforcement agencies must act quickly and take the necessary action," she added.

# High time to clean up our act

### New litter law will boost tourism appeal, say industry players

PETALING JAYA: The new law against litterbugs can help improve Malaysia's image as a tourist destination, particularly in urban centres and natural attrac-tions, where cleanliness signifi-cantly influences visitor experi-ence, says the Malaysian Tourism Federation (MTF).

Its president Datuk Tan Kok

Liang said unsightly streets and polluted beaches may discourage return visits and word-of-mouth recommendations.

"The proposed amendments, if strictly enforced and accompa-nied by strong public awareness campaigns, could lead to longterm improvements in cleanli-

"Over time, such actions would enhance Malaysia's reputation as a well-maintained and eco-conscious travel destination, appealing to domestic and inter-national tourists."

He added that fast-tracking the amendments would ensure that

Malaysia presents a cleaner, more welcoming image before Visit Malaysia 2026.
"A cleaner environment con-tributes to positive visitor experi-ence, enhances Malaysia's reputation as a sustainable travel desti-nation and aligns with global eco-tourism trends.

"If the amendments are imple

mented and enforced effectively before the campaign, Malaysia can showcase its commitment to cleanliness and sustainability to international tourists," he said.

He said having litterbugs clean the streets in uniforms could be a strong deterrent against littering, reinforcing accountability and discouraging repeat offences.

"However, ensuring that such measures do not appear overly punitive or create negative per-ceptions among tourists is essen-

"If handled properly – emphasising rehabilitation and civic duty rather than public shaming – this approach could be considered a firm yet constructive step towards a cleaner environment."

Clear communication regard-ing the rationale behind the policy would be key to maintaining a positive image, Tan noted.

He said the Visit Malaysia 2026 campaign can incorporate antilittering efforts by launching nationwide awareness pronationwide awareness pro-grammes, partnering with tour-ism stakeholders to promote responsible waste disposal and integrating clean-up initiatives into tourist hotspots. "Special incentives could be introduced for businesses that maintain cleanliness standards,

while 'green tourism ambassa-dors' could encourage sustainable

dors' could encourage sustainable practices among visitors.

"Additionally, educational campaigns, including multilingual signage and digital campaigns, can inform tourists about the penalties for littering and the importance of environmental responsibility," he added.

"I have been following JjK's walking tours for six years and found their events to be informative and interest


ing," said Mok.

# Understanding the 'values' of wastes





OMPARED to 25 years ago, awareness of envi ronmental issues among the public and businesses in Malaysia has increased significantly, with more environment-related terminologies and concepts being introduced, from "reduce, reuse, recycle (3R)" to "sustainable development", and now "ESG" and "circular economy". The mainstreaming of these

concepts across all businesses is particularly important to ensure that business entities play their part in caring for the environment while generating profits or wealth from their operations.

Similarly, from the Government's perspective, significant progress has been made in many areas, with numerous comprehensive plans, guidelines, policies, blueprints and

regulations developed over the past few decades.

Ironically, despite these advancements, many people may not be aware that there are a total of 136 waste disposal sites across the country, nearly 85% of which are still non-sanitary or open dumpsites

The lack of budget allocation for final disposal has led to the mismanagement of most of these sites, resulting in serious impacts on both the local population and the surrounding environment.

Currently, the Government is planning to shift from conventional landfilling to waste-to-energy (WTE). The Housing and Local Government Minister (KPKT) Nga Kor Ming had announced the Government's plans to build 18 WTE plants across the country by 2040,

claiming that this initiative will be able to turn waste into wealth.

#### Waste to wealth' should be interpreted carefully

We often hear terms like "waste-to-wealth", "trash-to-cash", or even "waste-to-money", but is this truly the case? Can waste be seen as an untapped resource? Can we consider waste as a reve nue stream? When we segregate and sell recyclables, such as old newspapers and plastic bottles, to recyclers or buy-back centres, we receive incentives, thus creating a small form of "wealth".

When companies operate recycling plants to convert plastics into recycled resins or produce fertilisers from food waste, they are likely generating much greater "wealth" from waste. The potential wealth from waste can increase further when a company signs a long-term concession agreement awarded by the Government, such as providing waste collection services in a state or building and operating a WTE plant.

Nevertheless, the "Waste-to-Wealth" concept should be interpreted carefully, as the examples mentioned above only represent part of the whole picture. Valuable items such as old newspapers and plastic bottles are segregated for a small financial return, but little attention is given to items with no apparent value, such as food waste, used disposable diapers, and even hazardous materials like fluorescent lamps and waste batteries.

These items are often discarded into general waste bins, ending up in disposal sites where they contribute significantly to pollution.

Similarly, on the other side of the story, when companies generate revenue from long-term contracts for building WTE plants or providing waste collection services, the real burden falls on the shoulders of the Government or taxpayers.

The Government has revealed that approximately RM3bil is spent annually on solid waste management and public cleansing in Malaysia. If waste is still portrayed as a source of wealth at the same time, this is highly misleading and contradicts the reality.

No government in the world has made waste management its primary source of income or wealth. Waste management remains a significant cost for all countries, whether developed or developing.

Therefore, the Government should be mindful that

promoting "waste-to-wealth" from their perspective is misleading. Instead, they should educate the public on the actual costs involved in proper waste management and emphasise that waste is a responsibility.

### Wastes that have no value shall not be neglected

Let's take a closer look on the values of wastes as a whole, we will then realise that only limited types of waste carry positive values.

#### Waste with positive value\*

Black and white papers, magazine papers, old newspapers, carton boxes; some types of plastics (e.g. PET, PE, PP), aluminium cans; recyclable metals, industrial E-wastes, certain type of glass bottles, certain type of household E-waste (e.g. air-conditioners, computers, mobile phones); certain type of food wastes (e.g. husks from food industries).

### Waste with low or negative value\*

Most of the food wastes; wood and green wastes; contaminated papers, tissue papers, carbon papers; paper straws, cups and containers; certain types of plastics (e.g. PS, PVC); plastic laminates; leather; rubber; certain type of household e-waste (e.g. washing machines and refrigerators); used batteries; non-recyclable metals; used beverage cartons; disposable diapers, lady napkins; medical wastes; agriculture wastes; fluorescent lamps; construction debris; tiles and ceramic; textiles; household and industrial hazardous wastes (e.g. insecticide spray cans, chemical wastes and more).

It is obvious that many types of waste require proper management, particularly safe disposal, to minimise their adverse environmental impacts. However, it is common for people to focus more on the value of waste, rather than how it should be properly managed, especially when the waste has little or no value, or when it requires payment for safe disposal.

Putting too much emphasis on the potential monetary returns from waste may lead to neglecting the need for proper disposal, causing low- or negative-value waste to be dumped in disposal sites. This highlights the dangerous side of focusing too much on the wealth that can be derived from waste, which may eventually reduce the willingness to invest in proper waste management in the long run.

### Be holistic when driving towards ESG

Waste management is a crucial and integral part of the ESG framework. Thus, fostering innovative thinking to create markets or turn waste into valuable items is essential.

Nevertheless, it is important to have a clear understanding that the focus should not solely be on

the potential value of waste. Instead, a holistic approach is needed to ensure that all waste is managed properly, nothing is overlooked, and, most importantly, there is a willingness to pay for appropriate waste management when necessary.

Waste cannot be wealth for everyone, and not all waste can generate wealth. If it were otherwise, we wouldn't have so many dumpsites across the country still requiring significant funds to

manage.

While "waste-to-wealth" may be a viable concept for businesses, it is not a reality for governments. We certainly do not want to create more waste and then believe it benefits the poor.



HE pessimist sees difficulty in every opportunity, the optimist sees opportunity in every difficulty, Winston Churchill once said. This insight perfectly encapsulates the mindset shift needed in waste management.

While many view waste merely as a problem to be discarded, adopting an optimistic perspective reframes the challenge as an opportunity, a driver of economic growth—an untapped resource that can be repurposed, recycled and transformed into something valuable.

In Malaysia, businesses have the potential to convert waste heading to overflowing landfills into profitable resources. Through innovative practices like recycling, waste-to-energy solutions and upcycling, discarded materials such as plastics, paper and organic waste can be turned into valuable products.

Energy generated from waste incineration can be sold to the grid, creating a new revenue stream. With this shift in mindset, waste could evolve into a resource that fosters both environmental sustainability and economic growth.

However, it is important to recognise that waste cannot be wealth for everyone, and not all waste is capable of generating profit. If it were, there wouldn't still be countless dumpsites across the country requiring significant funds for proper management.

### Harmonising with the green shift

Besides being seen as a problem, waste is also often regarded as a cost. If a business is willing to leverage its existing network, waste can be collected from a site, repurposed or directed to recycling facilities, opening up the potential to generate revenue.

# The hidden value of waste

Repurposing waste is an opportunity to innovate, reduce costs and create new revenue streams, fostering a sustainable future through collaboration and a circular mindset

Waste Management Association of Malaysia (WMAM) executive committee technical chairman Zamri Abdul Rahman and its technical and research committee co-chair Low King Hserng states that shifting from seeing waste as a burden to recognising it as a valuable resource requires businesses and individuals to adopt a circular mindset, driven by innovation, collaboration and a commitment to sustainability.

"Embracing circular economy principles enables businesses to rethink their models to ensure waste is integrated into their production processes. Businesses can turn waste into opportunities by embracing circular economy principles and integrating waste into their production processes," says 7amri

"By prioritising reusable and repurposable materials, companies can drive sustainability. For example, IKEA's Buy-Back Programme resells or refurbishes old furniture, while Dell transforms old electronics into new products through its e-waste recycling programme, generating value from waste," says Low.

value from waste," says Low.

They highlight that shifting from a traditional approach to a circular economy also involves designing products with recyclability and reasability in mind. For example, the CAREton Project, a collaboration between Tetra Pak—which actively promotes food packaging recycling and other sustainable initiatives—and Nestlé Malaysia, has collected over 4,700 tonnes of used beverage cartons since 2012.

The materials were then recycled into roofing tiles and panel boards to support housing projects for Malaysia's Orang Asli communities.

"Collaborations with researchers or waste management firms can also lead to innovative solutions. Petronas' circular plastic initiative, which repurposes plastic waste into high-value resin, exemplifies

how cross-industry partnerships can drive progress," says Zamri.

Low adds that on an individual level, adopting a zero-waste lifestyle is key to shifting one's mindset. "Viewing waste as a resource opens up possibilities—used coffee grounds can be composted and orange peels can become natural cleaning solutions.

"Everyday actions, like upcycling glass jars or repairing clothes, reduce waste. Supporting businesses that promote sustainability, like Patagonia's focus on reselling and repairing apparel, or Nike Grind's transformation of old shoes into sports surfaces, further encourages a circular economy." says Low.

Both emphasise while it is imperative that waste repurposing must balance environmental responsibility with financial viability, companies can integrate waste-to-value strategies while maintaining profitability.

# Are we letting women's potential go to waste?

Smart economics: Empowering female talent for a more resilient and prosperous nation

F the entire world were one colossal machine, each of us would have a part to play, wouldn't we? In the context of the labour market, it's much like a vast engine, driven by the ideas and hard work of millions of people.

However, when the potential of intapped talent is neglected, it effectively auses the engine to operate on just one sylinder. If that is so, it's hardly surprising hat the economy isn't running at full hrottle as it could be. This is especially evident in Malaysia, where the underutilisation of women's talent remains a significant factor in this inefficiency. Despite epresenting nearly half of the population, women continue to be significantly underepresented in the workforce.

As of 2023, the female labour force paricipation rate in Malaysia stood at 56.2%, howing a marginal increase from 2020's 5.5% and 2021's 55.9%—compared to 2.3% for men. This stark gender gap in mployment means that a vast pool of otential talent is not being fully leveraged.

### Vomanhood penalties

But it is not just about participation in he workforce. Women face numerous arriers, including wage disparity. Even then they do enter the workforce, they re often paid less than their male counarparts for the same work.

For instance, female teachers in falaysia were excluded from pension, nedical and housing benefits, a disparity nat persisted until the 1970s. They also earned lower wages than their male counterparts.

Despite years of efforts and advocacy, the nation's gender pay gap remains significant, with women earning an average of RM42,080 annually, compared to RM63,117 for men. According to the Department of Statistics Malaysia (DOSM), the median monthly salary for female workers was RM2,464 in 2023, while men earned RM2,675 for overall jobs.

This means women were paid, on average, 7.9% less than men—an increase from the 4.9% gap in 2018. While there are now more female professionals in various fields—about 6,400 more than men—women still earn approximately 19% less than their male counterparts.

The persistence of the gender pay gap is embedded in systemic factors that have been reinforced over time and continue to shape women's economic outcomes. While progress has been made in terms of women's participation in the workforce, educational attainment, and professional development, these advancements have yet the stanslate into equal pay and opportunities.

translate into equal pay and opportunities. A core issue is occupational segregation, where women, often due to societal expectations or unconscious biases, are overrepresented in lower-paying sectors like healthcare, education, and retail. These fields, while valuable, have historically been undervalued and underpaid, contributing to the wage gap. Additionally, the roles women hold often lack the financial rewards seen in male-dominated sectors.

The underrepresentation of women in leadership worsens the issue. Studies show women are less likely to be promoted, limiting their earnings. Despite high performance and competence, they face barriers to further advancement when they reach senior roles.

It was reported that Malaysian women hold only 13.51% of the seats in the House of Representatives, with 30 out of 222 parliamentarians being women. The Inter-Parliamentary Union's (IPU) global ranking for women's representation in national parliaments ranked the nation 150th out of 190 countries in 2024.

The nation has also not seen the appointment of a female prime minister, chief minister or menteri besar—unlike neighbouring countries like Singapore and Thailand, which have had women in top leadership roles.

Meanwhile, cultural norms continue to play a significant role. In many societies, including Malaysia, the expectation that women bear the primary caregiving responsibilities often leads to career breaks or even complete exits from the workforce.

Evidence also suggests some women choose occupations that pay less but provide more flexibility to accommodate their family care responsibilities. Data from the Khazanah Research Institute shows that 3.1 million women, constituting 62.9% of those outside the labour force, cite family responsibilities as their primary reason for not seeking employment. This contrasts sharply



with a smaller percentage of men, only 2.3% or 50,500, attributing their decision to similar reasons. Meanwhile, unpaid care work, traditionally carried out by women, remains one of the most significant contributors to the global gender pay gap.

Studies in other parts of the world have found that women caregivers outearn men if they were paid for their work. It was estimated that the value of unpaid work carried out by stay-at-home mothers would be approximately £184,820 if they were paid for their contributions. This figure accounts for the wide range of roles women undertake as caregivers, including childcare, cooking, cleaning, shopping and managing household finances.

Another analysis of 800,000 earnings reports over 20 years shows that regardless of pay, or education, all mothers get hit with the "motherhood penalty". On average, they lose out on about US\$8,000 a year with the birth of their first child, while fathers' incomes do not take a meaningful hit.

### Female economic might

Research has consistently shown that empowering women to access equal wages and workforce opportunities not only benefits individuals but drives positive change across entire economies and societies.

Socially, empowering women promotes more inclusive communities. Studies show that women's participation in decision-making processes leads to policies that are more likely to focus on health, education and family welfare, which improves the overall quality of life.

The World Economic Forum's 2024 Global Gender Gap Report highlights that countries with greater gender equality, such as Iceland and Norway, often experience higher levels of social well-being, increased life satisfaction and improved health outcomes for all citizens.

Additionally, financially empowered women are found to reinvest more in their families and communities. The United Nations estimates that when women earn income, they invest up to 90% of it back into their families and communities, compared to just 30% to 40% for men.

Economically, the inclusion of women in the labour market is proven to have a significant impact on growth. According to the McKinsey Global Institute, closing the gender gap in the workforce could add a staggering US\$28 trillion to the global GDP.

In fact, companies with more women in leadership positions tend to have higher financial returns, as demonstrated by a 2019 report from Credit Suisse, which found that companies with women at the helm had a 26% higher return on equity than those led by men.

Closing the gender pay gap is a strategic economic choice. Given that Malaysia currently holds the Asean chairmanship, this presents an opportunity to reshape the region's gender equality landscape and unlock substantial economic benefits, ensure long-term sustainability and foster a more prosperous, equitable society – leveraging it for regional progress.

The economic and social benefits of empowering women are clear. So, why, despite overwhelming evidence, does gender inequality persist in the workplace and beyond?





Ia susulan persetujuan pihak Kuil Dewi Sri Pathrakaliamman berpindah ke lokasi baharu untuk memberi laluan kepada pembinaan masjid baharu milik Kumpulan Jakel di tapak berkenaan.

Perdana Menteri berkata, kerajaan mengambil pendekatan berhikmah termasuk berunding dengan pihak kuil bagi memastikan pembinaan masjid itu berjaya direalisasikan.

"Negara ini harus tegak sebagai negara yang aman, hanya negara yang aman yang keselamatannya terjamin," katanya ketika berucap pada Majlis Pecah Tanah Pembangunan Masjid Madani di Lot 328, Jalan Munshi Abdullah di sini, semalam.

Turut hadir, Timbalan Perdana Menteri Datuk Seri Fadillah Yusof, Menteri di Jabatan Perdana Menteri (Wilayah Persekutuan) Datuk Seri Dr Zaliha Mustafa dan Pengarah Urusan Kumpulan Jakel Datuk Seri Mohamed Faroz Mohamed Jakel.

Kontroversi kuil Dewi Sri Pathrakaliamman bermula apabila struktur semasanya yang terletak di Jalan
Munshi Abdullah, dikatakan dibina pada 1893, beberapa dekad sebelum Dewan Bandaraya Kuala
Lumpur (DBKL) dan agensi
pendahulunya ditubuhkan.

Selepas merdeka, DBKL menjadi pemilik tanah terbabit, sebelum dijual kepada Jakel pada 2014.

Jakel baru-baru ini, mengumumkan rancangan untuk membina masjid yang akan dinamakan Masjid Madani atas tapak berkenaan.

# Awas taktik tipu dalam talian sempena Aidilfitri

Kuala Lumpur: Polis mengesan kewujudan satu modus operandi penipuan baharu yang mengambil kesempatan sempena kedatangan Aidilfitri dengan menggunakan nama sebuah platform jual beli dalam talian terkenal.

Pemangku Pengarah Jabatan Siasatan Jenayah Komersial (JSJK) Bukit Aman, Datuk Rohaimi Md Isa, berkata sindiket itu dikesan mengubah suai poster promosi dengan meletakkan nombor telefon mangsa, kononnya sebagai pemenang dalam peraduan.

"Mangsa kemudian akan dihubungi oleh pihak sindiket dan diarahkan untuk mengaktifkan kemudahan (pembayaran) bagi menebus hadiah kemenangan mereka.

"Setelah diaktifkan, mangsa akan menerima satu kod QR yang perlu diimbas, namun sebaik sahaja imbasan dilakukan, mangsa mendapati wang dalam akaun bank mereka berkurangan," katanya dalam satu kenyataan, semalam.

Rohaimi berkata, setakat ini satu laporan diterima di Selangor membabitkan kerugian berjumlah RM3,006.03 dan ia sedang disiasat mengikut Seksyen 420 Kanun Keseksaan iaitu kes tipu.

Beliau menasihatkan orang ramai lebih berwaspada ketika melakukan pembelian secara dalam talian, terutam menjelang musim perayaan ini.

Katanya, dalam tempoh 1 Januari hingga 24 Mac lalu, sebanyak 2,328 kes penipuan belian dalam talian direkodkan dengan jumlah kerugian mencecah RM19.6 juta.

"Jumlah ini menunjukkan peningkatan sebanyak 36.9 peratus berbanding tempoh yang sama tahun lalu, di mana sebanyak 1,700 kes direkodkan dengan nilai kerugian RM13.6 juta.

"Justeru, kami menyeru masyarakat supaya lebih berwaspada dan tidak terpedaya dengan tawaran terlalu menarik yang digunakan oleh sindiket penipuan," katanya.

Jumlah ini menunjukkan peningkatan sebanyak 36.9 peratus berbanding tempoh yang sama tahun lalu, di mana sebanyak 1,700 kes direkodkan dengan nilai kerugian RM13.6 juta

# KL not ready for congestion charge

> Improved public transport, phased rollout, equity measures keys to future implementation: Experts

KUALA LUMPUR: While a congestion charge could ease traffic in Kuala Lumpur, experts warn that several critical issues must first be

addressed.

Malaysian Institute of Road Safety Research (Miros) head of corporate communications and knowledge management Dr Hizal Hanis Hashim said the main goal is to encourage public transport use to ease congestion, improve infrastructure efficiency, boost road

mprove initiative and contently soos to a safety, and lower carbon emissions.

Miros, in collaboration with the Malaysia Green Technology and Climate Change Corporation, is currently studying the feasibility of implementing the charge in the capital.

Hizal said public transport readiness is the most crucial factor in determining the success of congestion pricing.

He noted that cities like Stockholm and

He noted that cities like Stockholm and Singapore had robust public transport networks before introducing such measures.

"For Malaysia, the MRT, LRT and bus services have made good progress, but further enhancement and expansion are needed to meet growing demand," he said.

If implemented, Hizal said a hybrid model using Automatic Number Plate Recognition (ANPR) and Radio Frequency Identification (RFID) would be the most viable option for the capital. This would allow integration with existing toll infrastructure to ensure efficient system operations.

system operations.

"Lessons from global cities suggest that for congestion pricing to work in KL, several key measures must be in place before implementation, beyond just improving public

implementation, beyond just improving public transport.

"This includes dynamic pricing that charges more during peak hours, transparent reinvestment of revenue into public transport and road safety, a phased rollout to test effectiveness, and seamless enforcement using ANPR and RFID."

Meanwhile, Universiti Putra Malaysia Road

Safety Research Centre head Assoc Prof Dr Law
Teik Hua said although congestion charges
have worked in other cities, Kuala Lampur's
urban layout and public transport limitations
require careful planning.
"Gurrently, only 20% of the city's commuters
rely on rall transport, which may not be
sufficient to support a major shift from private
vehicles if a congestion charge is introduced.
"Expanding services like MRT3 and
introducing integrated ticketing are necessary
to provide a reliable alternative," he said.
Law said congestion pricing could reduce
traffic by 15% to 20%, based on international
examples, with fewer vehicles on the road
leading to fewer collisions and better road
safety.

leading to this safety.

"There would also be significant environmental benefits," he added, citing Stockholm's 10% to 14% drop in emissions and London's 10% to 14% drop in emissions and London's 13% reduction in nitrogen dioxide levels after implementing congestion charges. He stressed the importance of addressing social equity concerns, suggesting exemptions or subsidies for lower-income groups to prevent

financial hardship.

To ensure a smooth transition, Law proposed a phased implementation.

"Starting with high-traffic areas like KLCC

and Bukit Bintang would allow gradual

adaptation.
"Exemptions or discounts could be offered to residents, low-income individuals and commercial vehicles during off-peak hours," he

The congestion pricing proposal was first raised by Minister in the Prime Minister's Department (Federal Territories) Datuk Seri Dr Zaliha Mustafa on Feb 27.

She said it could cut traffic by up to 20% while being the control of the country of th

She said it could cut traffic by up to 20% while bringing long-term economic benefits such as improved business access and increased pedestrian activity.

However, Transport Minister Anthony Loke clarified in the Dewan Negara on Tuesday that the government has no immediate plans to implement congestion charges in Kuala Lumpur.

Lumpur. Yesterday, Loke reiterated that the charge

remains a last resort.

"Forget about that (congestion charge), it's
the last option in our minds. We do not want to
add to the burden of the people," he said at the
Rapid KL On-Demand event at the Rapid Bus
depot in Maluri here.

He stressed that the government's priority is to improve public transport services, not to impose new charges.

### 14,000 pigs culled so far in Selangor to curb ASF outbreak



SHAH ALAM: The Selangor Veterinary Services Department has culled only 14,000 pigs suspected of being infected with African Swine Fever (ASF).

Fever (ASF).

Its director Dr Hassuzana Khalil said the culling was conducted using carbon dioxide gas, with carcasses buried on pig farms in accordance with established guidelines.

To date, 58 farms in Sepang and Kuala Langat have been affected by ASF and issued disposal orders under Section 19 of the Animals Act 1953 (Act 647) to prevent further spread of the disease. the disease.

"The culling process at infected farms is

costly and requires a large workforce, involving support from other state department offices and the veterinary services headquarters in Putrajaya," she said in a media statement.

She was replying to a statement by state infrastructure and agriculture committee chairman Datuk Izham Hashim on Wednesday, who said the department had culled about 76,000 pigs from 57 farms in Kuala Langat and Sepang last week due to ASF infections.

Hassuzana added that pigs from 52 ASF-negative farms are still permitted for slaughter at licensed abattoirs, subject to strict regulations by department.

"One of the conditions is strict adherence to designated transport routes, ensuring pig transport vehicles only travel to licensed abattoris;" she said. The department has also opened seven

investigation papers under Sections 34 and 36 of the Animals Act 1953 following Op ASF, an enforcement operation carried out in outbreak

zones.

Hassuzana warned that pig farms in Selangor remain at high risk (Category 3) due to inadequate biosecurity measures and their close proximity — only 0.5 to 1km apart — which increases the likelihood of ASF transmission.

"It is expected that ASF infections will continue, as there is currently no available vaccine for the disease," she said.

To curb the outbreak, the department has issued disinfection orders under Section 23 of the Animals Act 1953 to all affected farms.

"Farmers are also prohibited from introducing new pigs until the infection is completely eradicated and Selangor is declared ASF-free," she added.

On Feb 25, it was reported that 1,868 of the 76,000 pigs in Kuala Langat and Sepang had been culled as part of containment efforts.
