They were drawn to WAW's environmental cause and saw that event-based food rescue missions were aligned with sustainable development goals that met their environmental, social and governance target.

WAW measures the weight of all their rescued food to calculate the amount of greenhouse gas (GhG) prevented from being released into the atmosphere and shares the data with its corporate clients.

Citing the United Nations guideline that 1kg of food waste in a landfill produces the equivalent of 2.5kg of GhG emissions, he said the 26.82 million kilogrammes of food rescued over WAW's five years of operations had resulted in 67.05 million kilogrammes reduction of GhG

The food rescued over the same period is valued to be over RM20mil.

According to Alvin, WAW had to date impacted 196,000 beneficiaries in Klang Valley, Penang, Johor and Perak, and worked with 130 corporate partners.

On digitalisation, WAW is trialling a beta version of its e-platform at six Ramadan bazaars, where it is offering its food rescue service under a collaboration with Subang Jaya City Council (MBSJ).

The six bazaars are located at USJ4, USJ7, SS19, Pinggiran USJ, Puchong Indah and Putra Heights.

"We're trying to get bazaar traders themselves to register as donors, since they are familiar with the type and weight of food they sell.

"The digitalisation process will make it easier when they drop off any unsold food at WAW's counter as they just need to scan a QR code to input the necessary details, as opposed to us having to manually weigh and calculate everything," explained Tan.

She said the number of fully registered traders on WAW's e-platform ranged from 20% to 30% in USJ4 and Puchong Indah while in SS19 and Putra Heights it was up to 90%.

"The challenge is in the number of stalls, as it's easier to register traders at smaller

New solar panel system to cut Sepang council energy bill by 20%

A NEWLY installed photovoltaic (PV) system at Sepang Municipal Council (MPSepang) building in Cyberjaya, Selangor, is estimated to reduce the local authority's electricity bill by 20%.

A PV system is composed of one or more solar panels combined with an inverter and other electrical and mechanical hardware.

MPSepang president Datuk Abd Hamid Hussain said the solar panels, with an estimated capacity of 470kWp (kilowatts peak) would generate approxi-

mately 602,409kWh in the first

year.
"MPSepang is expected to save RM105,422 in the first

save RM105,422 in the first year.

"The solar panels installation is a 20-year contract, which means MPSepang is expected to save RM6,345,016.

"This is in line with the council's Cyberjaya Smart and Low Carbon City 2025 and vision for a clean, green, smart and sustainable municipality by 2030, in support of Sustainable Development Goals," he said at the PV system launch at MPSepang headquarters.

Abd Hamid said the supply

agreement-renewable energy contract was signed on Dec 17, 2021.

MPSepang signed the contract with Tenaga Nasional Bhd and its wholly owned subsidiary, GSPARX Sdn Bhd, a company that provides solar solutions.

"The solar panels were installed in four months, between April 18 and Aug 12 of 2022, while the licence to fully operate it was obtained on Dec 7 last year," said Abd Hamid.

"I hope more similar energy saving initiatives will be taken and the council will be a benchmark for other departments and corporations in Sepang."



The PV system installed at the MPSepang building roof is expected to save RM105,422 in the first year of the system installation contract.

RM1.5mil synthetic football field for Taman Kepong

KUALA Lumpur City Hall
(DBKL) has approved a synthetic football field to be built in
Taman Kepong, at an estimated
cost of RM1.5mil.
Kepong MP Lim Lip Eng said
the project was approved in a
special budget application meeting and would take off in
October.

"The field will be built on Lot
19226 in Jalan Kuang Gunung,
which has been a gazetted open
space since 1996 to be used as a
green lung or for recreational
purposes.

"The plan for the site includes
a full-sized turf field for football
that can also accommodate two
small-size pitches, as well as a
straight running track, longjump pit and small seating
area," he said.

Lim said that while he welcomed the project, he hoped
DBKL would consider making
changes to the design such as

omitting the long-jump pit and seating area, and instead include public facilities like toilets. "I foresee very few people

"It is better to use the space to build toilets," he said. Lim said if all went well, it

would be the first synthetic football field in Kepong. "There are two grass football fields, one in Jinjang Utara that is in good condition and another in Metro Prima that is in need of improvement," he said.

He also appealed to Kepong residents to let him know of any idle land that could be upgraded into recreational areas.

"This particular land was a green lung filled with overgrown trees and bushes in the past.

"I had proposed that the land be used for recreational purposes," he said.

Lim also said that DBKL had cleared the land some parties tried to scam people into renting the

Food handlers in hot water

DBKL fines Ramadan bazaar traders for unhygienic food items

A TOTAL of 82 compounds and notices were issued to traders of Ramadan bazaars in Kuala Lumpur for selling contaminat-

Lumpur for selling contaminated food.

Kuala Lumpur City Hall
(DBKL) collected 1,060 food
samples from various bazaars
operating in the city, from
March 10 to 29.

Of the collected samples,
11.9% (126) were found to be
contaminated with bacteria.

"Food samples collected were
sent to DBKL's Analysis Centre
and Food Security (FoSAC) facility located at Pasar Borong Kuala
Lumpur for testing,

"The samples were inspected
for the presence of
Staphylococcus, E. coli and coliform bacteria," DBKL said in a
statement.

The presence of the bacteria

The presence of the bacteria was indicative of unclean food preparation, inadequate cooking or unsatisfactory personal hygiene of the food handlers, said DBKL.

Compounds were issued as operators had contravened the Food Handlers (Federal Territory) By-laws 1979, where by-law 6(1) states that "no person shall sell any article of food which is not clean or contains any matter foreign to the nature of such food."

Under the by-law, errant operators could be fined up to RM2,000 for the offence.

DBKL said it also inspected 2,404 operators at the various

"This included not having food exposed and not placing ice blocks on the floor.

"Traders were also reminded of the 'zero single-use plastic' initiative and to use biodegradable packaging."

This year, DBKL said there were 64 Ramadan bazaar locations throughout the city.

Of these, two are under DBKL's management – the Aidliffiri Bazaar at Lorong Tuanku Abdul Rahman (216 lots) and Ramadan Bazaar at Taman Tasik Permaisuri (160 Taman Tasik Permaisuri (160

lots).
Over 4,000 lots at the other 62 locations were managed by private operators.
The bazaars are expected to operate until April 9.



Ringgit ends higher as dollar retreats on selling activities

THE ringgit ended higher against the US dollar yesterday as the greenback retreated on selling activities after the US ISM purchasing managers' index for services report showed that price pressures are easing, said an analyst.

At 6pm, the ringgit rose to 4.7380/7425 against the US dollar from Wednesday's close of 4.7545/7575.

Bank Muamalat Malaysia Bhd chief economist Mohd Afzanizam Abdul Rashid said the ringgit gained some good ground yesterday following weak outturn in the US ISM index for the services sector to 51.4 points in March which has been on a downward spiral from as high as 69.1 points on December 2021.

"Such data points support the view that the Federal Reserve will commence its monetary easing this year. It is a question of the timing for the eventual rate cut which continues to affect market

sentiments," he told Bernama.

At the close, the ringgit was also traded lower against a basket

of major currencies except the Japanese yen.

It depreciated against the euro to 5.1445/1494 from 5.1192/1224 at Wednesday's close, weakened vis-a-vis the British pound to 6.0002/0059 from 5.9769/9807, but was better versus the Japanese yen at 3.1222/1254 from 3.1329/1351 previously.

The ringgit was traded higher against Asean currencies except

for the Singapore dollar.

The local note was higher versus the Thai baht to 12.9048/12.9223 from 12.9519/12.9653 on Wednesday and improved vis-a-vis the Indonesian rupiah to 298.1/298.5 compared to 298.6/298.9 previously.

It was also higher versus the Philippine peso at 8.40/8.41 from 8.42/8.43 at yesterday's close but slipped against the Singapore dollar to 3.5172/5208 from 3.5159/5183 previously.

air bersih. Ini menyebabkan pertambahan permintaan terhadap air bersih, sekali gus mem-beri tekanan kepada sektor perkhidmatan bekalan air yang berdepan cabaran keku-rangan sumber disebabkan proses penyejatan ce-pat di empangan dan sungai. Dalam konteks keterjaminan makanan, kadar

hujan rendah boleh menyebabkan hasil pertanian berkurangan akibat penyejatan air dalam tanah berlaku dengan pantas dan mengurangkan kelem-bapan tanah, manakala sayuran tertentu mendapat

bapan tahan, manakan sayuran tertentu mendapa manfaat daripada cuaca panas pula dijual dengan harga lebih tinggi berdasarkan permintaan. Tidak kurang juga sektor penternakan, akual-kultur dan perladangan yang memerlukan cukup sumber air untuk penghasilan komoditi bagi memenuhi permintaan terutama musim perayaan. Kesan rantaian perubahan cuaca ini mencetuskan situasi seperti kenaikan harga makanan, pembe lian panik dan kebergantungan produk makanan import yang perlu diberikan perhatian serta tindakan segera oleh pihak berwajib kerana ia pasti membebankan kewangan rakyat.

Kesihatan masyarakat turut terjejas ketika kemarau kerana cuaca kering dan panas memberi impak signifikan dengan kenaikan suhu serta ri-siko jerebu.

Antara risiko kesihatan sering dikaitkan musim kemarau ialah strok haba, keletihan, kekejangan otot, kesihatan kardiovaskular, penyakit respitori dan peningkatan penyakit bawaan vektor.

Oleh itu, aktiviti luar wajar dihadkan bagi mencegah risiko kesihatan meskipun diakui ia sukar dibuat kerana keluarga, saudara dan sahabat mengambil kesempatan untuk berkumpul pada mu-



sim perayaan. Namun, masyarakat perlu bersedia mengubah gaya hidup untuk beradaptasi dengan

'Federal govt increases allocations to states'

KUALA LUMPUR: The National Finance Council has given the nod to the federal government to increase allocations for state governments this year.

Prime Minister Datuk Seri Anwar Ibrahim said, in a statement, that the council had agreed on RM8.9 billion worth of allocations for state governments this year, compared with RM8.3 billion last year and RM8.1 billion in 2022.

Anwar, who chaired the council meeting yesterday, said the agreement was in line with the federal government's commitment to collaborate with state counterparts in developing the nation.

The allocations, outlined in the 2024 Budget, included an increase in road maintenance grants to RM5.4 billion compared with RM5.2 billion last year, and Economic Development Infrastructure and Welfare Development-Based funds amounting to RM400 million.

The Ecological Fiscal Transfer grants were increased to RM200 million compared with RM150 million last year.

Additionally, annual grants to Sarawak and Sabah, amounting to RM300 million each, were approved, an increase from RM16 million for Sarawak and RM129.7 million for Sabah last year.

There would also be an increase of 10 per cent in grants for state libraries and museums this year, he said.

For development expenditure, RM39.4 billion was allocated this year to execute state development projects, reflecting an increase from RM36.7 billion last year and RM28.8 billion in 2022.

government applications had been granted regarding preparedness to face emergencies or natural disasters, such as floods and landslides, which might cause damage to roads and bridges.

"There's also an increase in the cap to finance expenses related to state road maintenance management by 10 per cent, or RM10 million, whichever is lower," he said

He said the increase in grants would involve all states and would be provided simultaneously.

He added that following this meeting, the government was determined to ensure that the relationship between the federal and state governments remained on good terms for the benefit of the people.

"This commitment is demonstrated through the increased grants and allocations for development expenditure in all states for 2023 and 2024."
